Beginning **February 10**, Dog Tag permits are also now available on our website with online payment at <u>www.whitewaterregion.ca</u>. Fees apply.

Council approved a Zoning By-law Amendment and Licensing By-law to legally permit the use of 1 Recreational Vehicle (tent/travel trailer, motorhome, etc.) on vacant waterfront and vacant rural zoned properties. This process will ensure that recreational vehicles are properly located on their respective properties, are disposing of septage adequately, and can be accessed by emergency services.

The process to permit a recreation vehicle on a vacant property is simple and cost effective. Simply visit our website, download the Application Form, and submit the completed form, along with a Site Plan and the applicable fee (2020 - \$150.00).

#### **Pushing Snow Across Roads**

It is a safety hazard and against the law. The Ontario Highway Traffic Act states, "no person shall deposit snow or ice on a roadway without permission in writing to do so from the Ministry or the road authority responsible for the maintenance of the road."

## **Fire Hydrants**

Clear access to a fire hydrant can save precious time during an emergency. If a hydrant is buried, it can be difficult for our firefighters to locate. Ideally, snow should be cleared away around the hydrant for three feet to provide room to connect the hoses.

## **Community Improvement Plan (CIP)**


