8. Delegation

1. Lyle Dupuis - Outdoor Wood Burning Furnace - Westmeath

Mr. Lyle Dupuis and his wife addressed Council with concerns about the outdoor wood burning furnace that is located next to their property.

Mrs. Dupuis informed Council that she had three main concerns:

1) Danger to children

2) Fire Hazard – ventilation and wood smoke and the chimney stack is in a tree

3) Smoke - their home has been filled with smoke three times.

The Dupuis are not able to open their windows because their home and garage fill with the smoke from the outdoor furnace.

Mrs. Dupuis stated that the smoke from the outdoor furnace has the same effect on humans as does cigarette smoke.

Mrs. Dupuis is also concerned that the furnace could run 12 months of the year to heat the hot water.

Mr. Dupuis was pleased to see the Fire Marshal Tawnya Roberts, Chief Heubner and Chief Building Official, Doug Schultz out today to inspect the outdoor furnace.

Chief Heubner informed Council that this was a site visit, a preliminary first step.

Reeve Rathwell stated that Whitewater Region is currently working on a By-Law that will take into consideration outdoor furnaces.

Councillor Trimm informed Council that the outdoor furnace owner is not planning on using it in the summer.

Chief Heubner informed Council that he will give an update when he has received the information from the Fire Marshal.

2. Rita Patterson - Park and Ride

Mrs. Patterson stated that she did not want to comment until after Council had made their decision.

3. Donald W. Deer - Park and Ride

Mr. Deer read over his letter that he had submitted to Council.

Mr. Deer stated that one good thing that came from the park and ride is that the Nature Trail is now usable.

Mr. Deer explained that he did not feel that it was in the best interest of the Township to pay the landowner rent for the area, when the owner before leased the property to the Township for \$1.00.

Councillor Trimm stated that Mr. Olmstead did not approach Council for money.

Councillor Trimm stated that the previous owner approached the Township to purchase the property from him and the Township did not see it as feasible to purchase the land.

Councillor Trimm stated that it was Council, through the former CAO who approached the new owner to lease the property for area residents to park vehicles.

Deputy-Mayor McBride stated that it was Mr. Kowalski who put up the kiosk to advertise his place of business and the Township paid the insurance through maintenance on the property.

Councillor Dick presented his survey to Council that he had taken over the period of September 4 – September 30, 2012.

Councillor Dick expressed to Council that parking areas are a root of business.

Departmental Report

September, 2012 Plants:

Aluminum Sulphate (Alum) was purchased early this month for the Cobden Waste Treatment Plant. We order roughly 10,000 Litres. Alum acts as a coagulant in the treatment process.

Truck #19 (Dodge ½ ton) will go into the body shop late this month for a repair to the box panel.

Electronic Actuator Valves at the Beachburg Water Treatment Plant are periodically malfunctioning. They are showing their age. I have one (1) quote so far (in the process of getting another) for valve replacements for consideration perhaps in the next budget.

The Department is investigating more viable sludge disposal options. Currently the Ottawa Plant (ROPEC) is our only option. We have to dispose of roughly 60 cubic metres of aerated sludge every 4 – 5 weeks. I anticipate having the field on Kohlsmith Road approved for the next season or two. Many surrounding Municipal Plants rely solely on land application of their bio-solids.

Terex Excavator is repaired and back at the Ross Landfill. It required a new Final Drive. With the finalization of the Stage I trench excavating and waste backfilling, as well as the anticipated Public Works Department Excavator purchase (a great back-up for the landfill), I believe the Corporation is now in a position to consider a change in primary equipment for future landfilling operations. The excavator has served its purpose extremely well for excavating the trench, loading/moving of materials and subsequent waste backfilling in sometimes very tight quarters. Without a doubt a very versatile piece of equipment. Over the next



few years as the Department continues to place monies into reserves for future equipment I would encourage Committee to perhaps consider a crawler loader now that stage I trench is complete. A crawler loader is also another very versatile piece of equipment for small landfill operations and I believe would suit perfectly as we now move upward in Stage II and incorporate "area landfill and cover" practices.

The Fall Household Hazardous Waste Event was held at the Ross Mineview Garage on September 15th.

The Department hosted a Public Consultation Event for Stage II Development of the Ross Landfill on the evening of September 19th. It was attended by several interested members of the public. The Public Event is a necessary part of the Application process for an amendment to our Provisional Certificate.

Reeves Renfrew County Report For the Month of September

Algamating Eganville and Beachburg senior Adult day program sites to the proposed location of the Parish of Stafford – Whitewater Anglican Diocese of Ottawa Parish Hall at 27 Crawford Street, Cobden, Ontario. For the period of January to August 2012 the County of Renfrew received 147 severance applications compared to 137 received over the same period in 2011.

A 20 Lot Plan subdivision approved for the Township of McNab/Braeside and a 19 Lot subdivision final approval for Town of Petawawa.

Taste of the Valley held in Renfrew in August with approximately 3,200 visitors, it is growing each year.

The last Taste of the Valley for 2012 will be held in Cobden October 123, 2012. Last year we had approximately 7,000 visitors. There are over a 100 vendors registered this year.

Renfrew County farmers continue to see effects of the drought as pasture land forage and corn crops suffer significantly from damage all ready done and continuing day conditions. The Federal Government has declared portions of Ontario and Quebec as drought stricken and this brings into force a Federal tax deferral program which enables livestock producers to sell their livestock and defer paying the income tax on receipts of such sales which are being made under drought duress.

The Rural Ramble has been transformed into an online fall touring event running from September 1 to October 31, 2012. The existing Rural Ramble themes Adventure and Exploration, Food, History, Heritage and Culture will continue to be promoted throughout the autumn season.

The Manager of Planning Services has been invited to speak before the Renfrew County National Farmers Union to discuss agricultural policies under the County of Renfrew Official Plan, including any possible changes under the 5-year process. This should help provide opportunity of the planning division to gain input on the Official Plan in terms of agricultural policies.
