7. Delegation

Consensus was received to move item 11. 1. Slope Stability Assessment/Site Plan – Patrick St. Michael up to this point.

Mr. John Cholewa from Houle Chevrier Engineering Ltd. spoke about the Slope Stability. Mr. Cholewa explained to Council that he was hired in July to assess existing slope at Mr. St. Michael's property.

Mr. Cholewa informed Council that he went out on July 24, 2012 and measured the shallow subsurface.

Mr. Cholewa then took the information back and ran a computer model.

Mr. Cholewa stated that the slope was 35 - 40 degrees and it would continue unless it was stabilized.

Mr. Cholewa came up with five suggestions regarding the slope:

- 1. Do nothing.
- 2. Slope regrarding earth work removal of vegetation

3. External toe buttress

- 4. Slope reinforcement
- 5. Protection from erosion.

Mr. Cholewa informed Council that it was agreed to go with the # 2 option of slope regarding. This step will add erosion protection and control the erosion with erosion control blankets.

Mr. Cholewa informed Council that there will be a retaining wall incorporated and the wall will be built to gain a 2 - 1 slope angle at the bottom.

Mayor Labow questioned if the wall would be higher as it get nearer the water

Mr. Cholewa informed Council that the wall would be higher nearer the water. Deputy-Mayor McBride questioned the construction material of the retaining wall.

Mr. Cholewa informed Council that the material is Armour Stone.

Councillor Trimm questioned what the erosion control mats were.

Mr. Cholewa explained that the blanket goes on top of the top soil and the blanket is there to keep the top soil and grass seed in place. The blanket stays in place until the vegetation takes effect and then the blanket disintegrates.

Councillor Trimm questioned about the excavation that is going on at the adjacent property if it would have any effect on the St. Michael's property.

Mr. Cholewa informed Council that he felt the excavation would not have any effect on the St. Michael's property.

Councillor Trimm questioned why an E.I.S. study was not needed?

Mr. Bruce Wheaton from Ontario Resource Management Group Inc. informed Council that Kristi Beatty went out and investigated the property and with the information that she gained she erected a desk top study.

Ms. Beatty along with Ms. Lorne Trute from the local Ministry of Natural Resources, Pembroke location.

Ms. Beatty and Ms. Trute main concern was the erosion and this problem is being handled through the slope regrading.

1. Janice Fricker – Reports – Pat. St. Michael Property

Ms. Fricker thanked Council for allowing her the opportunity to speak.

Ms. Fricker explained that the property was purchased in 1967 from Mr. Gould and was basically a cow pasture.

Ms. Fricker explained to Council that her main concern was the trees that her parents and family members had planted on the property.

Ms. Fricker explained that her Dad had taken three steps in from the property line and planted the trees.



Ms. Fricker explained that the pictures of tree's roots being exposed worried her and that is why she was here.

Ms. Fricker stated that she found pickets on her property and thought they might be the severance pickets from the original severance of her parents.

Ms. Fricker informed Council that she is happy with the slope regarding because it was explained to her that the trees would not be damaged.

Councillor Trimm informed Council that he had gone to the St. Michael's property and investigated the Fricker property. Councillor Trimm stated that the two large pine trees on the edge of the Fricker property were 25 feet and 30 feet away from the crest and he assured Ms. Fricker that the trees would not be disrupted.

2. Shelley & David Anderson – Reports – Pat. St. Michael Property

Mr. and Mrs. David Anderson thanked Council for their opportunity to speak. Mr. Anderson explained that the survey pickets that Councillor Trimm saw were the survey pickets for the Anderson lot addition.

Mr. Anderson explained that his concerns are for the hydro wires when the slope regarding takes place.

Mr. Anderson was adamant that he did not want a hydro pole on his property.

Mr. Anderson also explained to Council that he does not want his property value to go down.

Mr. Anderson stated that there is now a new foot print on the property because of the new cottage and septic system.

Mr. Anderson explained to Council that he gave Mr. St. Michael access to his property through Mr. Anderson's property.

Councillor Trimm asked for clarification on the moving of the septic bed and septic tank. Mr. St. Michael explained to Council that the septic bed was not moved, but the tank was moved.

Mr. St. Michael also informed Council that there is a large steel mattress on top of the septic bed and then it is covered with soil.

Mayor Labow called for a vote on the slope stability.

Consensus everyone was in favour.
