PAYMENT TO SCHOOL BOARD AND COUNTY

The first installment of the County and School Board levies was due at the end of March; \$584,738.00 was paid to the County, \$382,767.38 was paid to the English Public School Board, \$90,012.79 was paid to the English Separate School Board, \$4,821.32 was paid to the French Public School Board and \$15,141.78 was paid to the French Separate School Board for a total of \$1,077,481.27.

2012 BUDGET

## T.W.P. Whitewater Region Departmental Report

## Department of PUBLIC WORKS

- March 2012 **Monthly Activities:**
- Trucks have been out on 6 weather responses this month, compared to 7 last year at this time Staff repaired a water break on Elliott St in Beachburg.
- Hauled sand to the Mineview garage in case it is required for sanding, the dome is just about empty from the amount hauled in the fall
- Snow banks were pushed back and ditches were opened early in the month hoping to prevent any flooding of the roads
- Culverts we regularly have problems with in the spring have been checked, cleaned out and opened up
- Cold patching is on going
- Ice has been removed from the Westmeath arena
- Culvert has been installed on McGonegal Rd
- The graders are out grading all gravel roads, to date the township is 75% complete
- Sweeping of intersections has begun
- Bromley Line was closed from Rapid Road to Wright Road due to soft, muddy area. All emergency response dispatches were contacted, no one lives on this section of road.
- Behm Line and Sturgeon Mountain had some gravel drawn to repair soft spots
- Trees were removed from roadways following the wind storm.

## Township of Whitewater Region Environmental Services Department **Departmental Report**

## March, 2012

## Plants:

Work was carried out on the Cobden Sewage Lift Station electrical control panel this month. Work was carried out by Xylem Inc. New pumps are on order and will be installed when they arrive.

The Annual Operations Report for the Cobden Wastewater Treatment Plant was completed and submitted to MOE. By-passing occurred at the Cobden Wastewater Treatment Plant for a period of 6 - 7 days during the middle of the month. Rapid snow melt, higher than normal temperatures caused a heavy hydraulic loading on the Plant. Flows were in excess of 2,500 cubic metres per day. Effluent quality was poor and the sludge blanket was rising in the clarifier. Staff lowered the weir to allow raw sewage to by-pass the treatment unit to lessen the load. Reporting on the by-pass event is carried out through the MOE Spills Action Centre as well as the Renfrew County Medical Health Unit.

## Waste:

Initial planning stages are underway for the Municipality with respect to Stage II expansion of the Ross Landfill Site. Jp2g has submitted proposed budget and scheduling to the Environmental Services Department for its review. Public Consultation will be part of the application process to have the Certificate of Approval amended. Costs for Consultation Services as well as Monitoring are expected to see an increase for the Ross Site while moving through the application process in 2012.

Landfill staff are currently underway cleaning up the Ross Site after the Winter months. On-site road conditions are excellent with minimal mud or wash-outs. Excavations conducted last Fall are proving to be beneficial for traffic congestion at the tipping face.

Hydrogeological Reports for the three (3) Waste Sites will be submitted to MOE before months end as well as an operational component for the Ross Site.
