August, 2012 Plants:

Reopened Service Truck Tender as there were no submissions on the July 26<sup>th</sup> opening. Received two (2) submissions (Butler Chevrolet and Mack Mackenzie Motors). Mackenzie Motors was awarded the Tender with a price of \$24,147.20 for a 2013 Chevrolet W/T four wheel drive extended cab. Truck has been ordered. Collected three prices for the supply and installation of three (3) natural gas furnaces for the Beachburg Water Plant.

J.W HVAC will be carrying out the job. An old electronic actuator valve at the Beachburg Water Plant has been malfunctioning. There are several within the plant. A representative from Rotork is coming to give prices on newer units for future consideration.

Had to order pressure switches for duty pumps at the Beachburg Water Plant. Also quite old components. Received the report from the Elevated Water Tower Inspection. Landmark Municipal Services suggested the interior and exterior coatings appeared good as did the structure itself. They did however identify over \$20,000.00 worth of Health & Safety apparatus / components that really should be installed. Access / egress, harnessing, rest platform, etc.

Truck #19 (Dodge Service Truck) was struck by a wheel that came free off a van. Right side panel on box will have to be replaced.

MOE Inspection has been scheduled for the Haley Drinking Water System for late in the month. I am in the process of involving our Drinking Water Systems into the MOE's Drinking Water Surveillance Program. This program has been in effect since the mid 1980's and its mandate is to sample and analyse raw water sources along with the treated water from roughly 80% of the provinces drinking water systems. Involvement is beneficial for providing a steady database of water quality analysis for respective Municipal systems. Hundreds of parameters (excluding Reg. 170 regulated parameters) are analysed and monitored several times per year. This program is not affiliated with MOE regulatory drinking water programs. Waste:

Moving landfilling operations into the low area at the North West portion of the Ross Site. Stage I trench has essentially been backfilled to the turning / tipping area for larger trucks. Numerous loads of gravel have been spread with a dozer at this lower area for traffic.

A Public Consultation Event for the Ross Landfill, Stage II Landfill Development, has been scheduled for September 19th, 2012. It will be held at 6:00PM in the Municipal Chambers (prior to regular Council Meeting). A brief formal presentation by the Environmental Services Manager explaining future development of the Site (Stage II) will be followed by a question period for the public as well as Council.

The Fall Household Hazardous Waste Event is scheduled for Saturday, September 15th, 2012 between (9:00AM -1:00PM).

Terex Excavator is down for an undetermined period of time. A Final Drive is gone due to an oil leak. Renting a large dozer for the interim.

Reeves Renfrew County Report For the Month of August

Due to the Extreme urgency of the drought condition in the County of Renfrew a Water Response Team (W.R.T.) was formed to coordinate the County response to the drought situation.

The District Manager of the M.N.R. and the County's Manager of Economic Development are the co-chairs of the W.R.T.

On a scale of 1 to 3 in drought situations it was declared Renfrew County is at level 2. The County will be funding the communications plan that will be implemented by the W.R.T.

By Resolution the County approved funds for W.R.T. to a maximum of \$30,000.00. In June and July the planning department received total 37 new severance applications.

For January 2012 to July 2012 the County received 141 severance applications, compared to 115 for the same period in 2011.

In June draft approved 378 – lot 10 Block sub division for Petawawa, 40 lot sub division for McNabe/Braeside and 324 - unit 3 block plan subdivision for Towns of Amprior.

The association of Ontario Road Supervisors has selected the County of Renfrew and the Town of Amprior to host the 2014 show and conference.



The Clerks and Treasurers conference has also been brought to the County and will be held in the Town of Petawawa in October 2012.
