# 8. Delegation – Donna Burns 7:00 By-Laws & private property

Mrs. Burns explained the purpose of her delegation is to express concern about the Council not paying attention to when passing by-laws and not paying attention to detail when approving conditions relating to a lot severance or when approving recommendations that are brought forward concerning new zoning and creating more "bad bylaws."

Mrs. Burns went over the attention to "detail" that she was paying to all items that she had observed when attending Council meetings. She went over the approved lot severances and explained that some were approved with recommendations from the County that needed to be met before it would go through.

Mrs. Burns informed Council that she had recently attended a Growth & Development Committee on the Official Plan. She questioned why Mr. Whitehead and Mr. Cheesman were the people that were allowed to generalize the objections to the Official Plan. She asked if Mr. Whitehead and Mr. Cheesman understood the Municipal Act or are they just required to know the Planning Act?

Mrs. Burns addressed the questions that she had put forward for that meeting and said that Mr. Whitehead disregarded her emphasis on Sec. 25 of the Planning Act and so did the Council.

Mrs. Burns ended saying that she does not envy the positions of Council, CAO or staff and that The Township Council and employees are expected to know so much, but that our first priority should be the protection of the Municipality.
