DEPARTMENT: Environmental S MONTHLY ACTIVITY: November, 2013

Third scheduled dive to repair the potassium permanganate system at the Cobden WTP Intake was conducted. Two (2) of the three lines going from the Plant to the Intake structure are no longer accessible or functional. Now down to one (1) line supplying the chemical to the Intake for Zebra Mussel control as well as Manganese control.

Ontario Clean Water Agency officially took over as the Operating Authority for the water and wastewater systems on the 12th of this month.

Large mulch pile at the Ross Landfill will hopefully be moved to the tipping face area early next month. The Public Works Department will carry this out as time allows.

All Fall groundwater monitoring events have been conducted at the three (3) landfills.

The annual topographic survey for the Ross Landfill Site has been conducted. This survey is included in the Annual Operations Report for the Ministry as is also used to calculate estimated volume of waste landfilled for 2013 (compacted and covered). The Department will be steering toward and recommending a small crawler loader (preferably with a waste package) for the new primary piece of equipment for the Ross Site. It is preferred that the Terex Excavator be kept for a back-up piece of equipment. Steven Hodson, Environmental Services Manager

Buckwalt's excavating is going to tear it down and prepare the site, we have drawings already made up and Green R Construct will be doing the slab. I will look for prices to frame it also. Reeves Renfrew County Report For the Month of November

During the month of November I attended three half day meetings and one full day meeting.

For period January to October 2013 the County of Renfrew received 136 severance applications compared to 168 over same period in 2012.

With respect to final decisions 116 decisions were rendered in the period January to October 2013 compared to 198 over same period in 2012.

By January 1, 2014 a plan on 10 year housing and homelessness plan must be submitted to Ministry of Municipal Affairs and Housing. WE submitted in August of 2013.

At November 27, 2013 session of County Council SHS Consulting made a presentation, one out 10 year for housing. Anyone wanting to read this plan I can provide the document. It is too large to make copies for everyone. A resolution was passed on Hydro rates:

WHEREAS increased electricity rates are challenging for Economic competitiveness of rural Ontario and for vulnerable groups within the Community that face financial challenges;

AND WHEREAS the current rates have had a detrimental impact on the economy of Rural Ontario impacting the competitiveness of the manufacturing forestry, mining, agricultural and other sector;

THEREFORE BE IT RESOLVED that The County of Renfrew encourages the Government of Ontario to ensure that our electricity rates both the short and long term allow out business to remain competitive in a Global environment and ensure that the vulnerable residents of our communities are not overburdened by ever-increasing electricity rates;

AND FURTHER BE IT RESOLVED that this resolution be sent to the Premier of Ontario, the Minister of Energy and Infrastructure, Eastern Ontario Warden's Caucus, The Ontario Energy board, The Ontario Power Authority, Association of Municipalities (AMO), MPP John Yakabuski, Ontario Municipalities and local municipalities in Renfrew County;

MONTHLY ACTIVITY: November, 2013

Third scheduled dive to repair the potassium permanganate system at the Cobden WTP Intake was conducted. Two (2) of the three lines going from the Plant to the Intake structure are no longer accessible or functional. Now down to one (1) line supplying the chemical to the Intake for Zebra Mussel control as well as Manganese control.

Ontario Clean Water Agency officially took over as the Operating Authority for the water and wastewater systems on the 12th of this month.

Large mulch pile at the Ross Landfill will hopefully be moved to the tipping face area early next month. The Public Works Department will carry this out as time allows.

All Fall groundwater monitoring events have been conducted at the three (3) landfills.

The annual topographic survey for the Ross Landfill Site has been conducted. This survey is included in the Annual Operations Report for the Ministry as is also used to calculate estimated volume of waste landfilled for 2013 (compacted and covered). The Department will be steering toward and recommending a small crawler loader (preferably with a waste package) for the new primary piece of equipment for the Ross Site. During the month of November I attended three half day meetings and one full day meeting. For period January to October 2013 the County of Renfrew received 136 severance applications compared to 168 over same period in 2012.

With respect to final decisions 116 decisions were rendered in the period January to October 2013 compared to 198 over same period in 2012.

By January 1, 2014 a plan on 10 year housing and homelessness plan must be submitted to Ministry of Municipal Affairs and Housing. WE submitted in August of 2013. At November 27, 2013 session of County Council SHS Consulting made a presentation, one out 10 year for housing.
