- Access
- Higher Speed up to 10Mbps
- Affordable rates

Mr. Pine informed Council that the EORN is on time and budget and that they need to be completed by March 31, 2014.

Mr. Pine informed Council that there are two new satellites in the air and they are helping make the internet access cheaper and faster.

Deputy-Mayor questioned if NRTCO responded to EORN.

Mr. Pine informed Council that the CRTC won't allow EORN to compete with NRTCO. Reeve Rathwell asked when Haley's area would be able to get high-speed.

Ms. Severson informed Council that by the end of the summer the work will be complete. Ms. Severson also informed Council that Bell would be marketing in the area when the work is complete.

### **MONTHLY ACTIVITY: January 2013**

**INTERIM TAX BILLS** 

The Interim Tax bills have been sent out with the 1<sup>st</sup> installment due February 28<sup>th</sup> and the 2<sup>nd</sup> installment due April 30<sup>th</sup>. The total dollar amount of the two installments is \$3,997,679.53. 2012 YEAR-END

The auditors are scheduled to begin the 2012 year-end audit around February 13<sup>th</sup>.

#### 2013 OMPF ALLOCATION

We have now received the first installment of the Township's 2013 OMPF allocation in the amount of \$263,750.00. Our total 2013 OMPF Funding allocation will be \$1,055,000. Additional OMPF payments will be received in April, July and October 2013.

## PRELIMINARY EDUCATION RATES

Ontario Regulation 445/12 has now prescribed the 2013 education tax rates. The residential education tax rate has decreased from 0.00221 (2012 year) to 0.00212 (2013 year). We will discuss the education tax rates later during the budget process.

#### 2013 BUDGET

Requests went out to the larger departments in the later part of 2012 to start working on their updated five-year capital plan. Environmental Services has now submitted their plan and staff will be meeting this week to review and discuss the proposal. Most 2012 year-end figures (pre-auditor) have also gone out to the departments so they can begin working on their 2013 budget figures.

- Some brushing was done along Service Road and Berts Road of trees that were obstructing the plow trucks
- Fire hydrants were made accessible with snow removal
- Received excavator although still needs some work as it is missing some requests that were in the specifications
- The sand shed at the Mineview Garage has been emptied this month (Jan) compared to the middle of March last year. We are now hauling sand into the dome to finish the winter; we will probably be
- hauling sand to the Westmeath sand dome by mid-February as it is almost empty as well.

#### Township of Whitewater Region Environmental Services Department Departmental Report January, 2013

#### **Drinking Water Systems:**

High Lift Fire Pump at the Beachburg Water Treatment Plant was pulled for repair. A "fist" sized hole was present in the casing. Therefore the pump was not able to get up to normal pressure. Department staff and Harrington Mechanical carried out the repair.

The Quality Management System Representative has carried out the first Internal Audit on its Drinking Water Quality Management System. The purpose and scope of the Audit is to see how the System / process is working and how it can be continually improved. An Audit checklist and a Final Report have been prepared for the Owner and the Operating Authority. The Audit file will close following a Closing Meeting.

All documentation for the Drinking Water Quality Management System will be forwarded to our Accreditation Body early next month.

#### Wastewater Treatment:

Received notification from the Ministry of the Environment that the Annual Plant Inspection for the Cobden Sewage Plant will be early next month.

Old gas furnace at the Cobden Sewage Plant had to be replaced this month.

#### Waste Management:

Final Drawings and completed application to amend our Environmental Compliance Approval for the Ross Landfill is complete and ready to submit. This will go to MOE Approvals Branch in Toronto. Steven Hodson, Environmental Services Manager

#### DEPARTMENT: Building and By-law Enforcement DATE: January 31, 2013 MONTHLY ACTIVITIES:

- Carried out building, plumbing, septic and By-law inspections and attend Meetings for future developments.
- Since January 01, 2013 we have issued one single family dwelling permits, one single family addition, one single family alteration and one accessory building and one septic tank replacement. We issued 5 building permits in January with a construction value of \$ 193,000.00.

## Reeves Renfrew County Report For the Month of January

During January I attended four full days and four half day meeting.

Under Social Services we see approximately 10% increase in 2012 over 2011 under Child Care Statistics approximately 6% increase over 2011.

Renfrew County Housing Corporation Board of Directors meeting held January 17, 2013 a resolution was adopted appointing Reeve Donald Rathwell as President/Chair and Mayor Mary Campbell as Vice-President/Chair of the Renfrew County Housing Corporation Board of Directors which is consistent with the structure of the Social Services committee.

On January 30, 2013 County Council passed the budget for Renfrew County for 2013 for a Capital General and all purposes in the amount of \$36,052,253. On \$100,000 assessment this will be approximately \$0.77 over the 2012 budget.

For period January – December 2012 County of Renfrew received 203 severance applications compared to 220 received over same period in 2011.

County of Renfrew approved fore plan for subdivision totaling 471 lots/units approved and draft approved plans of subdivision totaling 993 lot units.

Economic Development Division Manager Mr. Alastair Baird will continue to participate in the on-going Renfrew County Water response Team core team meetings. In 2013 \$20,159.15 in advertising was spent in 2012 on the drought in Renfrew County. .Donald Rathwell
