Reeve Rathwell informed Council that he remembered the year in 2005-2006 that it flooded and people were upset that the Township allowed them to build in a flood area.

Mr. Lynch explained to Council that he moved to the waterfront to have as a residence and he would like to put in cement pillars 1-1.5 inches above the ground level so that the cottage would be above the elevation so that it would not flood.

Mayor Labow questioned if there was a well.

Mr. Lynch informed Council that he drilled a well last year and the septic is on the opposite side of the cottage.

Mr. Cheesman informed Council that they need to keep in mind that there might be a trend of these rezonings and that the decision will reflect on the next one.

Drinking Water Systems

The Operating Authority conducted its closing meeting for the Internal Audit on the 1st of the month. Discussed at the meeting was the Internal auditors final report as well as his findings. The Drinking Water Quality Management System Representative is the Internal Auditor for the Drinking Water Systems. The Auditor found three minor non-conformances which were exercised in Corrective Action Requests. All Internal Audit material was forwarded to SAI Global Auditor.

The SAI Global External Audit was conducted on the 22nd. This was conducted to see if the Operating Authority could achieve accreditation. The Auditors report was received on the 26th and included two (2) major non-conformances, two (2) minor nonconformances and several Opportunities for Improvement. Accreditation may be offered after following through on these Corrective Action Requests.



Annual Report on Water Taking was submitted to MOE this month.

New valves installed on the conventional package filter in the Beachburg Water Plant. Some issues with electrical and logic during the installation as well as some agitation of treated backwash water resulting in discoloration of water in the clearwell. A few water complaints were received immediately following. Valves operational and functioning well.

The Township of Bonnechere Valley took our aerated sludge (60 cubic metres) this month.

An effluent valve on the conventional package filter at the Cobden Water Treatment Plant created problems for a few days. Dave Simmons was brought in to troubleshoot with the Operators. Problem rectified.

A power issue occurred late in the month where both the Cobden Water Treatment Plant and the Wastewater Treatment seemed to lose a phase of the three phase power. Full power was restored in the evening following the power disruption but the main control panel in the Water Treatment Plant failed. After much troubleshooting by the Operators along with Dave Simmons, the old Filter #1 was operated manually through the night to supply water to Cobden. A failed transformer in the main control panel was determined to be the result. The new Filer (#2) cannot be as effectively operated manually. It is imperative the old filter be maintained for the future.

Wastewater Treatment

MOE conducted their annual inspection of the Cobden Wastewater Treatment Plant around the beginning of the month. The inspection report should be received in early March.

Annual operations report for the Cobden Wastewater Treatment Plant completed and submitted to MOE this month.

Waste

Completed, signed Environmental Compliance Approval application submitted early this month to MOE. Jp2g Consultants Inc. put together the application along with a current, detailed hydrogeological report and an operational document. Very well prepared application and documents for Stage II of the Ross Landfill will go to MOE's Technical Services Section in Kingston as well as the Approvals Branch in Toronto.

Late this month the Department received an e-mail from Emily Tieu, Senior Environmental Officer with the Ottawa District Office of MOE with respect to operations at the Ross Landfill.

The approved volume of the Stage I Trench (59,935 cubic metres) will be realized very soon according to the annual topographic surveys conducted. It is quite realistic the volume has already been exceeded as the Department has been landfilling outside of Stage I Trench perimeters since late last summer. Emily feels the Department waited much too long to submit the application for Stage II approval and is not confident that approval will be granted before the Municipality exceeds the Stage I volume. Furthermore... whether the volume of 59,935 cubic metres has been realized or not by landfilling outside of the perimeter of the approved trench we are in violation of Fill Beyond Approved Limits (FBAL). Emily has ordered by April 2nd, 2013 a written plan of how the Municipality plans on managing its waste until approval is granted for Stage II (could take an estimated 6 months – several years). Also by June 1, 2013 all in-place, compacted and covered waste in the lower Northern portion where landfilling has been recently occurring (outside of the Stage I Trench), shall be removed. The e-mail was followed up by a phone conversation with Emily.

Reeves Renfrew County Report For the Month of February

During February I attended four Half day meetings.

Rate of mileage changed January 1, 2013 from \$0.53 per km to 0.54 per km for the first 5000 kilometres and from \$0.47 to 0.48 for all kilometers over 5000 per year.

The Ontario Works Division Child Care Division Renfrew County Housing Corporation will move into a new facility at 80 McGonegal St., Arnprior on Tuesday February 26, 2013. The April meeting of Social Services Committee will take place at the new facility. Arrangements will be made to coordinate an official opening.

At the Good Roads (ROMA) in Toronto Warden Emon and myself met with Minister Jeffrey on what is happening in regards to the Drummond Report that was presented February 15, 2012 to the Provincial Government with its recommendations to reduce the deficit from our current 15 billion dollars from schools to homelessness outworks child care, drug programs and senior benefits.

The County received a cut of approximately \$700,000.00 in Social Services starting January 1, 2013 from the province.

The Ministry of Transportation is undertaking a 5 year review of the transportation Environmental Study report for Highway 17 Phase 3 and 4 from Arnprior to 3 km west of Bruce Street Renfrew.

At County Council we received and accepted a Strategic Plan the first for Renfrew County. I will be getting a copy for out CAO. This might help as a guide for Whitewater Strategic Plan. When I was Warden of Renfrew County in 2010 we developed an Action Plan for 2010 to 2015. I will also give out CAO of Whitewater Region a copy and it may be of interest to our Chair of Property, Growth and Development, Councillor Dick to get a copy of this document. We have 178 residents in Bonnechere Manor and 164 residents in Miramichi Lodge.
