#### **DEPARMENT: TREASURER**

**MONTHLY ACTIVITY: October 2014** 

#### **BOAT LAUNCH REVENUE**

Payment was received for a fishing tournament which was held on the Muskrat Lake in August. The amount received was \$250 and this is for 50 boats.

#### ONTARIO COMMUNITY INFRASCTRUCTURE FUND (OCIF)

New \$100 million annual fund will be allocated to municipalities for critical infrastructure.

- \$50 million for formula-based funds will support critical municipal road, bridge, water and wastewater projects.
- \$50 million for application based funds for eligible municipalities.

We have received the letter from the Ministry of Agriculture, Food and Rural Affairs advising us of our amount of funding from the OCIF program that the Township of Whitewater Region will be receiving over the next 3 years. The amount was based on the FIR and tax ratios from MPAC.

## This allocation amount will be advised once the province makes a formal announcement.

#### PROCEDURAL AUDIT

MacKillican & Associates will be conducting our procedural audit during the week of Nov 24th.

#### **ACCOUNTS RECEIVABLE**

We have now transferred \$65,201.59 in accounts receivable to the property taxes for collection as per the Accounts Receivable Policy. We now have \$24,632.46 outstanding to be collected in A/R. out of that amount only \$7,947.57 is 60 days + overdue. Collecting efforts have been in process.

## NEW OPP ANNUAL BILLING STATEMENT

The 2015 cost for policing have been delivered. It is now going up to \$214.89 per property from approx \$185/household. Originally, the expected cost for 2015 was as high as \$260/household.
