7. Delegation – 6:02pm Helen Francis, Marilyn Labow: Annual Whitewater Library budget submissions

Marilyn Labow and Ann Guest were in attendance to present their annual Whitewater library budget and answer any questions that may arise from the budget handout. Councillor Regier thanked the library board for all of their hard work and dedication. Mrs. Labow advised that they would be making special efforts to fundraise \$4000 towards the Forester's Falls Library which will be separate from the \$9000 fundraising amount to be divided amongst all of the libraries. CAO FitzSimons advised that now the library budget will be added as a budget item to the Township's budget to be passed.

6:10pm - Jon Pitcher - East Energy Pipeline

Mr. Jon Pitcher of East Energy Pipleline presented council with an Ontario project overview. He answered questions regarding the maintenance and integrity of the pipelines once the change between natural gas and oil happens. He also spoke to the benefits of the change including the creation of thousands of jobs both directly and indirectly between now and the anticipated in service date of 2020. Mr. Pitcher identified that they will keep us in the know as the project wears on.

6:38pm Norman Leblanc: garbage & recycling contract

Mr. Norm Leblanc, Mr. Joey Trimm and Mr. Vincent Gervais attended council to present a petition in support of Mr. Leblanc's tender for garbage collector and discuss with council the reasons Mr. Leblanc felt he was not awarded the tender despite being the lowest bidder. Mayor Johnson thanked Mr. Leblanc for being open to coming in and discussing his concerns with council. He advised that decision regarding the contract has been made in good faith and that despite Mr. Leblanc being unsuccessful this time, Mr. Leblanc is always welcome to submit bids for any tender. Reeve Millar reiterated the Mayor's sentiment and council accepted the petition for review.

UPPER OTTAWA VALLEY MEDICAL RECRUITMENT COMMITTEE

The Upper Ottawa Valley Medical Recruitment Committee approved their per capita amounts which will be billed for their 2015/16 budget. The per capita amount for the said budget has decreased to \$0.40 compared to the \$1.00 per capita as per the agreement. (See attached budget)

The Township of Whitewater Region will be billed \$2,336.80. The reason for the decrease per capita is as followed;

- U.O.V.M.R.C no longer has a recruiter on staff
- They are no longer maintaining a wait list
- They advise callers to call health connect

I spoke with Bruce Lloyd and he has advised me that the committee is seeking a different avenue in the future; they are working on putting together an agreement for succession planning for doctors who are retiring. When and if this agreement blooms, each municipality will be offered the opportunity to join this agreement or not.

Currently, we have two outstanding contracts with U.O.V.M.R.C. Contract#4 with Dr. Thomas and contract#7 with Dr. Gauthier.

SUMMER STUDENTS FOR 2015

We have been successful in our grant application for summer Jobs Services with Algonquin College for the hire of five summer student positions. This grant will reimburse the Township \$2.00/hrs towards the cost of the student's wages.

The approval amount is a total of \$2,640 towards the cost. If I were to break down the cost of these positions, it would be;

MONTHLY ACTIVITY: March 2015

Trucks have been out plowing/sanding/salting or removing Snow 7 days this month, compared to 11 days the same month last year.

Snow is being removed in places where flooding issues have occurred in years past.

Graders have been out pushing back banks and cutting ice off roads to allow water to get away during the thaw.

Finish cleaning up trees along Fletcher Road near Klaesi's Farm.

Brushing Fletcher Road with the excavator and brush head and moved to Pleasant Valley Road at Lapasse Road to chip brush and trees.

Many calls this month for water services freezing up. Steamer being used to unthaw what we are able. Areas with problems have been asked to run a trickle of water to keep the pipes from freezing again.

Crews have been out steaming culverts after the extremely cold winter.

Some Bump signs have been put up at trouble areas.

Half loads were held off until March 30th this year as the weather permitted.

DEPARTMENT: Building and By-law Enforcement Date: April 09, 2015

MONTHLY ACTIVITIES:

- We are busy getting the Foresters Falls Library Project organized start date for construction is Monday April 13, 2015.

- We are busy trying to get drawings prepared for the Beachburg Arena and three quotes for an accessibility grant for the end of April deadline.
- There was three Building Permits issued in April so far. One demolition, one single family addition and one single family dwelling.
- We have been working on some new business moving to our area.
- We have been working on severances, minor variances, re-zonings and building permit. We seem to be very busy with minor variances and re-zonings this year.
- We have been working with BEI to get the paper work in place to start developing the old Grain Mill property, they have submitted a rezoning application for the property
- I will be installing the signs at lockout tower next week, so that project will be completed.

Chief Building Inspector Doug Schultz added to his report that the drawings for the Beachburg arena are complete and we are now shovel ready should we be successful in the pursuit of the accessibility grant. Further Mr. Schultz has 3 contractors attending to give a quote on April 16, 2015 for the cost of the required renovations.

Mr. Schultz advised council that the renovations on the Forester's Falls library started on Monday April 13, 2015.

WHITEWATER REGION DEPARTMENTAL REPORT

DEPARTMENT: Environmental Services Department

MONTHLY ACTIVITY: April, 2015

Annual Topographic Survey of the Ross Landfill is complete and it determines a volume landfilled of 9,400 cubic meters for 2014. This value includes daily and intermittent cover materials (sand, mulch and clay). This leaves a theoretical remaining capacity of 234,000 cubic meters for the Ross Landfill.

The annual Operational and Hydrogeological Reports for the Landfill Sites have been prepared and submitted to the Ministry (March 31st deadline).

Attended the Ontario Recycler Workshop presented by Waste Diversion Ontario Continuous Improvement Fund. The workshop focused on the Arbitration of 2014 as well as the financial state of the Continuous Improvement Fund and program performance.

The Department is putting together a Financial Plan for the Drinking Water Systems. Drinking Water System Licenses are expiring in June 2015 and in order to renew there must be a Financial Plan in place which forecasts 6 years beyond renewal date.

The Annual Waste Diversion Datacall reporting is due April 24th, 2105. This reporting system focuses on the Municipalities blue box program costs and performance. The annual funding we get to help offset the cost of blue box is determined from this reporting.

The Department will be budgeting to have extensive accessibility upgrades carried out at the Cobden Visitors Centre for 2015. This will be an item for discussion during budget meetings.

The Department will be putting forth an estimated budget amount to hire a part-time landfill operator for the Ross Waste Site. This individual is will essentially work a three day week with opportunity to further cover full time staff holidays.

In the month of March I attended at County three times. Development & Property Committee on the 10th, Finance &Administration on the 13th and the regular Council meeting on the 25th.

Mr. Beakley has been tasked with the coordination of Family Day to be held on August 15 from 11am. until 3pm. in Pembroke at the County of Renfrew Building at 9 International Drive. So far this event will include the Wardens Family Day Dunk Tank Challenge Fundraiser for the United Way, Little Ray's Reptiles, a rock climbing wall, bouncy castle and an inflatable maze. Also, a BBQ and other activities.

The 2015 Ottawa Valley Road Map is ready with one hundred thousand maps being printed and will be distributed to OVTA members, Ontario tourist information centres and other businesses across Ontario. New in 2015 is that the OVTA is using CTM media group to distribute the maps to the Ottawa and Toronto airports and train stations as well as downtown hotels in Ottawa and Gatineau (estimated audience of 5 million plus).

An update of the status of the new OPP facility in Renfrew was presented by Kevin Valiquette, Manager of Real Property. The project seems to be on schedule for a base building completion by January 31, 2016 and a target date of August 2016 for occupancy. Project cost to date are \$125,539 towards a total project budget of about 5.3 million dollars.
