1. OCWA Annual Reports - Presentation by Brad Sweet

Brad Sweet presented the annual reports from Cobden, Beachburg and Haley's water treatment plants. He explained the where each plant is at capacity wise and also discussed any issues that arose in 2014 and how they were handled. He identified that all water facilities are in good shape with no foreseen problems. The sewer report was also reviewed. There were problems identified with respect to capacity and infrastructure. Questions were raised about sites for spreading sludge. Councillor Jackson requested that any letter submitted to CAO FitzSimons or Environmental Services Manager Steven Hodson be presented to council when there has been a determination made about where the sludge will go. CAO FitzSimons identified that she would coordinate with Mr. Hodson when a recommendation is made.
