Chief Building Inspector Doug Schultz joined the meeting at 7:10pm.

#### 3. OICF funding – Project identification – staff recommendation

CAO Christine FitzSimons led discussions around the costs associated with the cast-in-place sewer repair and the Ontario Infrastructure Community Fund (OICF). She identified that the Environmental Services Department was budgeting \$135,000 (inclusive of a 15% contingency) to carry out the repairs in 2015. The OICF funding will consist of \$54,900 annually for the next three years. The intended use of the funds is to complete the cast-in-sewer repair.

Environmental Services Manager, Steve Hodson identified that this is a project that will require no excavation to complete and that there are approximately 3 dozen locations to repair along the line from Dixon Street to just west of the dentist's office.

Chief Building Inspector Doug Schultz spoke to the cancellation of the minor variance meeting. He identified that the reason for the cancellation was because a committee of adjustments has not been appointed by bylaw. He noted that at the council meeting scheduled for February 18, 2015 the committee will be appointed by by-law and the minor variance meeting has been rescheduled for the Committee in Council meeting on March 4, 2015.

2. Delegation 7:20 pm BEI – Mark Enright – proposal for development of property

Mark Enright and Matt Nesmith from BEI were in attendance to discuss a proposal for development of property in the Whitewater Region. They discussed both the Wren Subdivision and its progress as well as the proposed development on Wallace Drive. They indicated that, although this matter has been before council in the past, they now have a viable business opportunity in Whitewater Brewing who would like to build a secondary site for their brewery with a tasting room. They indicated that investment of water and waste water services at this site would be an investment in the community and the potential would be there to generate revenue from other business who may wish to utilize the site as well.
