2.a Council Remuneration – moving forward

Discussion regarding the council remuneration turned to whether or not council wanted to have the Director of Human Resources for the County of Renfrew, Bruce Beakley assemble a panel and evaluate council remuneration and present council with information with which to decide on an increase or not. The decision was tabled until the May 6, 2015 committee meeting so that a decision can be made with all council members present.

3. Frequency of Council & Committee Meetings

Councillor McLaughlin suggested that the number of council meetings is too infrequent. He added that he felt there should be two council meetings per month with a committee meeting preceding each when necessary. Councillor Jackson reminded council that there is a provision in the procedural by-law for special meetings to be called whenever necessary. At this time, Councillor Jackson suggested that things remain as they are and see what happens in the fall, after budget and hope that the length of council meetings straighten out.

4. Accessibility Grant application

Staff is seeking direction for application for the accessibility grant. There are two viable options, however, CAO FitzSimons advised that making two applications from the same Township would not be looked on favorably and that only the first one received would be reviewed. It was noted that council needs to proceed immediately as the due date for this application is April 27, 2015. Council instructed staff to get drawings completed so that we are shovel ready.
