MONTHLY ACTIVITY: August 2016

Grading and Dust Suppressant on gravel roads finished this month

Crews are busy with road construction, Government Road has been surface treated and crews have been busy working on Grants Settlement installing sub drains and ditching where required. Greenwood Paving has been scheduled for early September to surface treat this road at 8.4 meters in width for the hardened shoulder for active transport.

Crushing was completed this month in Dunnes Hill pit for the Grants Settlement road iob

Cold patching is on-going, students have been working at this as required

Crews worked at brushing in the park in Cobden where some dead branches and low hanging branches were causing issues.

National Grinding offers best price this year for the grinding of the leaf & yard waste pile as well as the clean lumber pile.

Received notice from MOECC that the two (2) groundwater monitoring wells (shallow and deep) to be drilled at the Beachburg Public School will be done in October. This is part of the provinces monitoring program on aquifer levels and ties in very well with what the Env. Services Department was suggesting for a Beachburg Aquifer Study.

No movement this month on having MNRF address their evaluation requirements on the wetland.

Six (6) month supply of Yellow Bags for curb-side collection ordered this month from Creative Bag in Mississauga.

Advertisement carried out late this month for the September household hazardous waste event.

Draft Report received from Jp2g Consultants on the Groundwater Supply and Aquifer Study for the Village of Beachburg. The Department hasn't quite completed the review of the draft report but a quick review would suggest, as expected, there is likely a need to soon re-develop or carry out maintenance on the dug well more than an inherent need to monitor levels of Jackson Lake and the underlying aquifer.
