- A presentation was received on the Comprehensive Zoning By-law Update, Growth Readiness Action Plan, and preparation of Development Standards. This work is being completed by EcoVue Consulting Services in partnership with SHCG. A joint provincial Municipal Modernization Program grant was received with the Township of Greater Madawaska to do this work. Public consultation will occur in 2022 with completion by summer.
- A site plan was adopted for a waterfront property on Lacroix Bay Road for water access only with parking area.
- An update was received on Muskrat Lake development requirements. Acid-based B soils required for new septic systems have been located on the east side of Muskrat Lake and in nearby pits. A Frequently Asked Questions document has been prepared.

- A tender was awarded for the purchase of a grader brush head, which will be installed on one of the Township's three graders.
- The tender for the trailer mounted hot box was also awarded. This equipment will improve pothole patching operations.

- An update was received on arenas. The Westmeath Arena will be opening in time for the holidays. Holiday Skates are planned, and a poster will be released soon. Sponsors are being solicited.
- An update was provided on recommendations of the Parks & Recreation Master Plan and Parks & Recreation Operational Review. The issue of size of motor and stocking of fish at Little Lakes was raised and will be examined further.

- Council unanimously agreed to have the mayor serve on Renfrew County Council following the 2022 election. The reeve position will be replaced with a deputy mayor elected at large.
- Firefighter on & off duty accident & insurance benefits were renewed for 2022. The Township pays the premiums for all members of the department. Total annual cost is \$7,336.68, which is a \$2,677.00 savings over 2021.
- Council reviewed the CAO's 2021 performance appraisal in closed session.
