# **RE: Flood Monitoring and Mitigation Measures**

# Whitewater Region, Ontario - April 26, 2024

The Whitewater Region Municipal Emergency Control Group (MECG) met this morning to review localized conditions and implementation per the Township Flood Readiness Plan.

This meeting follows the Ministry of Natural Resources and Forestry's April 26, 2024, Conditions statement – Flood Watch, advising watershed residents of the rising levels along the main stem of the Ottawa River which could potentially cause flooding in low-lying areas and areas with poor drainage over the weekend and the coming week (low-lying areas are those that are regularly flooded during the spring freshet period). The situation is being monitored by the Township. As a preparedness measure, Municipal staff and members of the Whitewater Region Fire Department are being trained on a sandbag filling machine this evening, which Renfrew County has recently acquired and will provide to the Township when necessary. The Township remains in continued communications with the Renfrew County Emergency Management Community of Practice Spring Freshet 2024 - including the Ministry of Natural Resources and Forestry (MNRF), Ontario Power Generation (OPG), the Ontario River Regulation Planning Board (ORRPB), Renfrew County and neighbouring municipalities.

# **Roads**

The Township's Public Works Department is monitoring roads for flooding and potential closures. Visual observations were conducted by Township staff which have observed some low-lying areas and roads in the Township experiencing minor flooding.

Municipal511.ca is being updated to report flooded roads as they become known. The Township advises residents in low-lying areas affected by flooding that access may be restricted by emergency services.

### **Mitigation Measures**

Residents who have been affected by high water and flow conditions in the past should take necessary action to protect/secure any vulnerable property in proximity to rivers and lakes and closely monitor developing conditions and regularly check for updated messages.

The Township is prepared to implement the necessary mitigation measures (i.e., sand and sandbags, site command, etc.) and are awaiting updated water level forecasts (precipitation, wind speed, and direction) to ensure an informed decision from the MECG.
