Pre-authorized payments have many benefits:

- there are no cheques to write out
- you won't have to wait in line to make a payment
- you'll save on postage and transportation
- you don't have to keep track of due dates of payments
- you'll avoid paying a penalty for missing a due date

PLAN# 1 -TAXES - FOUR PAYMENTS

On each due date the tax installment will be automatically withdrawn from your bank account. Each year, you will receive your Interim and Final Property Tax Bills which will indicate the amount and instalment dates.

PLAN #2 -WATER / WASTEWATER - SIX PAYMENTS

On each due date the water and/or wastewater installment will be automatically withdrawn from your bank account. Each year, you will receive by-monthly water bills which will indicate the amount and instalments dates.

PLAN# 3 -TAXES - MONTHLY – 20th of each month / next business day

Your taxes will be automatically withdrawn from your bank account in twelve equal payments, starting January of each year. To allow our office time to process your application, please submit your application by the 1st OF THE MONTH that you would like your withdrawal to start. Each year, you will receive your Interim and Final Property Tax Bills which will indicate the monthly amount to be deducted. The deduction amounts are recalculated when the Final Property Tax Bills are sent out.

PLAN # 4 - WATER / WASTEWATER - MONTHLY – 20th of each month / next business day

Your water and/or wastewater will be automatically withdrawn from your bank account in twelve equal payments starting February of each year. To allow our office time to process your application, please submit your application by the 1st OF THE MONTH that you would like your withdrawal to start.

ARE YOU ELIGIBLE?

- If you own property in the Township of Whitewater Region you can take advantage of this convenient program;
- You can enroll any or all of your properties in this program;
- Your initial application is valid until cancelled by you. You do not have to reapply every year.

SUPPLEMENTARY TAX BILLINGS

During the year, if there is a supplementary tax bill, you will be notified and given the option of paying the supplementary bill on the installment due date, or increasing your monthly payment, or having your tax account adjusted in December.

WITHDRAWAL OF INFORMATION CHANGE

If you have information changes, or want to withdraw from the pre-authorized plan, please notify the Finance Department in person or in writing by the 1st day of the month. A \$50.00 service charge will be applied if funds are returned by the bank. This privilege may be canceled if two installments fail to be honored in the taxation year
