## REHABILITATION OF CAMERON STREET, EARL STREET, AND VERA CRESCENT

Dear Resident,

In January, the Township of Whitewater Region retained Jp2g Consultants Inc. (Jp2g) to finalize the design for Cameron Street and complete the engineering for Earl Street and Vera Crescent.

## **Project Description**

The project area includes approximately 1.2km of road rehabilitation in your neighbourhood.

- Cameron Street from Beachburg Road (County Road 21) to Vera Crescent
- Earl Street from Cameron Street to Cardel Street
- Vera Crescent

The construction work proposed includes grading, granular base, hot mix paving, concrete curb and gutter, concrete sidewalk, storm sewers, water system, and landscaping.

## **Project Result and Timing**

With the short timeline for the engineering design, the project is currently out for tender, and construction is planned to begin spring/ summer with completion in fall of 2022.

## Funding

Council of the Township of Whitewater Region has funded the rehabilitation of Cameron Street, Earl Street, and Vera Crescent in the 2022 budget through a long-term debenture.
