REHABILITATION OF CAMERON STREET, EARL STREET, AND VERA CRESCENT

June 9, 2022

Dear Resident,

H&H Construction Inc. (H&H) has been awarded the construction project for the rehabilitation of Cameron Street, Earl Street, and Vera Crescent. Jp2g Consultants Inc. (Jp2g) will continue with the project performing construction administration.

Project Description

The project area includes approximately 1.2km of road rehabilitation in your neighbourhood.

- Cameron Street from Beachburg Road (County Road 21) to Vera Crescent
- Earl Street from Cameron Street to Cardel Street
- Vera Crescent

The construction project includes grading, granular base, hot mix paving, concrete curb and gutter, concrete sidewalk, storm sewers, water system, and landscaping.

Schedule

H&H will be starting construction on Monday, June 13, 2022. The construction will take place this summer and estimated to be completed by October 28, 2022. H&H will be starting with setting up temporary water, construction on Vera Crescent and the pathway between Earl Street and Vera Crescent.

Construction Location

The construction will take place within the Township's right-of-way but may result in some disruption to your private property. Lawns and driveways may be disturbed but will be reinstated at no cost to you. However, if you have any assets located within the Township's right-of-way that you want to preserve, we suggest that you relocate these items in advance of the construction work.

Road Closure and Traffic

Traffic delays can be expected as lane closures and flagging operations may take place during construction. Road closures and detours are expected during the construction. Road closures will be communicated by email and on the project website www.whitewaterregion.ca/projects. Road closure can also be viewed on Municipal 511 www.municipal511.ca.

Garbage and Recycling

Curbside garbage and recycling collection will remain the same practice, but the contractor may bring bags and containers to a central location for pickup. Your containers will be returned to your property after collection. We ask that you mark your address on any cans or containers.

Water Outages/ Temporary Water

During the construction project, water outages are expected but will be communicated in advanced of the outage. Water outages will only take place throughout the day. Some residents will be connected to a temporary watermain to allow for construction of a new watermain. Regular testing will take place by Township's water operator, Ontario Clean Water Agency.

Building Condition Survey

H&H Construction Inc. has retained Englobe to complete a preconstruction survey of all homes and buildings within the project area. We encourage participation in this survey as it provides protection to private assets and a baseline for possible claims.
