

By-Law No. 13—1867.

A By-Law to authorize the Levying and Collecting of certain sums of money, or Rates therein mentioned,

Whereas it is necessary to Levy and Collect on all the rateable property within the Township of Westmeath in the County of Renfrew, the several hereinafter mentioned sums of money, for the following mentioned separate purposes, viz:— the sum of one thousand four hundred and thirty-four  $\frac{61}{100}$  dollars for the purposes of the County of Renfrew, the sum of three hundred dollars for the General School Fund, and the sum of four hundred and seventy— dollars for the purposes of the said Township of Westmeath,

And Whereas the Trustees of the undermentioned School Sections within the said Township of Westmeath, have by Petition, prayed this Council to Levy and Collect upon all the rateable property within the said several School Sections, for Special School purposes, the several sums following, that is to say;— In School Section No. 1. the sum of one hundred and ninety-five dollars, In School Section No. 2. the sum of two hundred and fifty dollars ———, In School Section No. 3. the sum of two hundred dollars ———, In School Section No. 4. the sum of one hundred and eight— dollars, In School Section No. 5. the sum of two hundred dollars, In School Section No. 6. the sum of two hundred and fifty-five dollars, In School Section No. 7. the sum of two hundred dollars, In School Section No. 8. the sum of one hundred and twenty dollars, In School Section No. 9. the sum of one hundred and twenty dollars, In School Section No. 10. the sum of sixty dollars, and in School Section No. 11. the sum of one hundred dollars.

Therefore, be it enacted by the Municipal Council of the Township of Westmeath, in the County of Renfrew, constituted and assembled by virtue, and under the authority of an

Act of the Parliament of Canada, intituled, "An Act respecting the Municipal Institutions of Upper Canada," and it is hereby enacted by virtue, and under the authority, of the same, that, the Collector for the said Township of Westmeath for the present year, shall Levy and Collect, and such Collector is hereby authorized and required to Levy and Collect the undermentioned Rates upon all the rateable property within the said Township of Westmeath, and also, to Levy and Collect the hereinafter mentioned Special School Rates upon all the rateable property within the aforesaid School Sections in the said Township of Westmeath. That is to say — A Rate of ten  $\frac{9}{100}$  Mills in the Dollar for the County of Renfrew, A Rate of two  $\frac{2}{100}$  Mills <sup>in the dollar</sup> for a General School Rate, and A Rate of three  $\frac{6}{10}$  Mills — in the Dollar for the Township of Westmeath, and also, for — Special School Rates, in the several School Sections mentioned, the Rates following, viz- in School Section No. 1. A Rate of fifteen  $\frac{3}{10}$  Mills in the dollar, in School Section No. 2, A Rate of 12  $\frac{7}{10}$  Mills in the dollar, in School Section No. 3, A Rate of thirteen  $\frac{15}{100}$  Mills in the dollar, in School Section No. 4, A Rate of fifteen  $\frac{5}{10}$  Mills in the dollar, in School Section No. 5, a Rate of twelve to Mills in the dollar, in School Section No. 6, A Rate of twenty-five  $\frac{5}{10}$  Mills in the dollar, in School Section No. 7, A Rate of six  $\frac{7}{10}$  Mills in the dollar, in School Section No. 8, A Rate of twenty  $\frac{2}{10}$  Mills in the dollar, in School Section No. 9, A Rate of nineteen  $\frac{6}{10}$  Mills in the dollar, in School Section No. 10, A Rate of ten  $\frac{1}{10}$  Mills in the dollar, and in School Section No. 11, A rate of twenty-seven  $\frac{9}{10}$  Mills in the dollar.
