

By-Law No. 6 - 1868.

A By-Law to authorize, the Levying and Collecting of certain sums of money or Rates therein mentioned.

Whereas, it is necessary to Levy and Collect on all the rateable property within the Township of Westmeath, in the County of Renfrew, the several hereinafter mentioned sums of money, for the following mentioned separate purposes, viz:— the sum of one thousand four hundred and sixty five dollars for the purposes of the County of Renfrew, the sum of three hundred and thirty dollars for the General School Fund, and the sum of four hundred and fifty two dollars for the purposes of the said Township of Westmeath.

And whereas, the Trustees of the undermentioned School Sections within the said Township of Westmeath, have by Petition prayed this Council to Levy and Collect upon all the rateable property within the said several School Sections, for Special School purposes, the several sums following, that is to say:— In School Section No. 1 the sum of one hundred and eighty dollars, in School Section No. 2. the sum of three hundred dollars, in School Section No. 3. the sum of two hundred dollars, in School Section No. 4. the sum of ^{four} Eighty Dollars in School Section No. 5. the sum of one hundred and sixty dollars, in School Section No. 6. the sum of One hundred and fifty dollars, in School Section No. 7. the sum of two hundred and fifty dollars, in School Section No. 8. the sum of one hundred and thirty dollars, in School Section No. 9. the sum of one hundred dollars, in School Section No. 10. the sum of eighty five dollars, and in School Section No. 11. the sum of

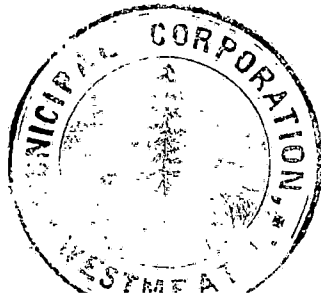
Therefore, be it enacted by the Municipal Council of the Township of Westmeath, in the County of Renfrew, constituted and assembled, by virtue, and under the authority of an Act of the Parliament of Canada, intituled, "An Act

respecting the Municipal Institutions of Upper Canada," and it is hereby enacted, by virtue, and under the authority of the same, that the Collector for the said Township of Westmeath for the present year, shall levy and collect, and such Collector is hereby authorized and required to Levy and Collect the under-mentioned Rates upon all the rateable property within the said Township of Westmeath, and also to Levy and Collect the hereinafter mentioned Special School Rates upon all the rateable property within the several School Sections aforesaid within the said Township of Westmeath;— that is to say,

A Rate of Eleven $\frac{35}{100}$ Mills in the Dollar for the County of Renfrew,
 A Rate of Two $\frac{56}{100}$ Mills in the Dollar for the General School Rate,
 A Rate of Three and one half Mills in ^{the Dollar} for the Township Rate,
 A Rate of Nine $\frac{6}{10}$ Mills in the Dollar ——— to defray the costs of Surveying the Blank line between the seventh and eighth Concessions between Lots numbers five and six and Lots numbers ten and Eleven as prayed for by Petition of the resident-landholders interested. and the following rates in the several School Sections as aforesaid. viz— in School Section No. 1. a rate of fourteen Mills in the Dollar, in School Section No. 2. a rate of fifteen $\frac{3}{10}$ Mills in the Dollar, in School Section No. 3. a rate of thirteen $\frac{7}{10}$ Mills in the Dollar, in School Section No. 4. a rate of twelve $\frac{7}{10}$ Mills in the Dollar, in School Section No. 5. a rate of Nine $\frac{7}{10}$ Mills in the Dollar, in School Section No. 6. a rate of sixteen Mills in the Dollar, in School Section No. 7. a rate of Eight $\frac{66}{100}$ Mills in the Dollar, in School Section No. 8. a rate of twenty two $\frac{2}{10}$ Mills in the Dollar, in School Section No. 9. a rate of fifteen $\frac{6}{10}$ Mills in the Dollar, in School Section No. 10. a rate of fourteen $\frac{59}{100}$ Mills in the Dollar, and in School Section No. 11. a rate of
