

By-Law No. 9 - 1868

A By-Law to authorize the payment of certain sums of money therein mentioned -

Whereas it is necessary to pay the several separate sums of money hereinafter mentioned,

Therefore be it enacted by the Municipal Council of the Township of Westmeath in the County of Renfrew, constituted and assembled by virtue, and under the authority of an Act of the Parliament of Canada, intituled, "An Act respecting the Municipal Institutions of Upper Canada", and it is hereby enacted by virtue and under the authority of the said Act, that the Trustees of School Section No. 1.

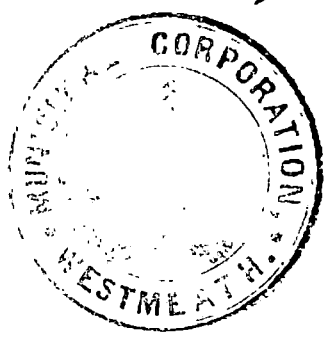
