

By-Law No. 14. — 1869.

A By Law to authorize the payment of certain sums of money mentioned therein.


Whereas, it is necessary to pay the several sums of money herein-after mentioned,

Therefore, the Municipal Council of the Township of Westmeath, in the County of Renfrew, constituted and assembled by virtue, and under the authority of an Act of the Parliament of Canada, intituled, "An Act respecting the Municipal Institutions of Upper Canada, enacts as follows—viz—
