

By-Law No. 22 - 1875.

A By-Law to authorize the payment of certain sums of money,
Whereas, it is necessary to pay the several sums of money
hereinafter mentioned;

Therefore, the Municipal Council of the Township of
Westmeath in the County of Renfrew, under the authority of an Act
of the Legislature of Ontario, intituled, "An Act respecting Municipal
Institutions in the Province of Ontario" enacts as follows, viz:—

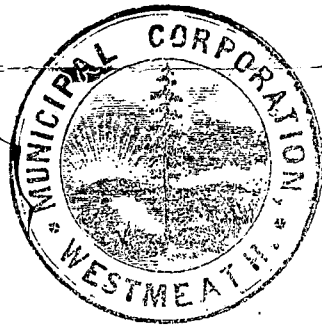
