

By-Law No. 9 - 1876.

A By-Law to re-divide the Township of Westmeath into Electoral Divisions and to establish Polling Places in each Division.

Whereas, it has become necessary to re-divide the Township of Westmeath in the County of Renfrew into Electoral Divisions and to establish a Polling Place in each of such Divisions;

Therefore, the Municipal Council of the said Township of Westmeath, by virtue, and under the authority, of an Act of the Legislature of Ontario, intituled, "An Act respecting Municipal Institutions in the Province of Ontario," enacts as follows:

Division 3 } That Lots Numbers, One to Five, inclusive, in the First and Second  
No. 1. } Concessions, East of Muskrat Lake; Lots Numbers, One to Fourteen  
inclusive, in the Third Concession, East of Muskrat Lake; the whole  
of the Fourth and Fifth Concessions, East of Muskrat Lake; Lots  
Numbers, One to Fourteen, inclusive, in the Sixth, Seventh and  
and Eighth Concessions; Lots Numbers, One to Six, inclusive, in  
the Ninth Concession; and Lots Numbers, Thirteen to Thirty, in  
clusive, in the East Front B, Concession; (all in the said Town-  
ship of Westmeath,) be, and are hereby formed into an Electoral  
Division, to be Known as Electoral Sub-division Number One;  
and that the Polling Place for said Sub-division be at the Town-  
hall in the Village of Beachburg in the said Township.

Division 1 } That the whole of the First and Second Concessions, West of Muskrat  
No. 2. } Lake; the whole of Concessions A, and B, East of Muskrat  
Lake; Lots Numbers Seven to Twenty-four, inclusive, in the North  
Front A, Concession; the whole of the First and Second Concessions,  
East of Muskrat Lake, excepting Lots Numbers, One to Five, inclusive  
in each of the said Concessions, Lot Number Fifteen and all to  
the North thereof in the Third Concession, East of Muskrat Lake;  
(all in the said Township of Westmeath,) be, and are hereby formed  
into an Electoral Division, to be Known as Electoral Sub-division  
Number Two; and that the Polling Place for said Sub-division be  
at the School House in School Section Number One of the said  
Township and Known as Moore's School House.


Division 3 } That Lot Number ~~Fifteen~~ in the Sixth, Seventh and Eighth Con-  
No. 3 } cessions and all to the North thereof in each of said Concessions; Lot  
Number Eleven and all to the North thereof in the Ninth Con-

Division } cession; the whole of the South Concession; Lots Numbers, One  
No. 3. } to Six, and twenty-five to thirty <sup>inclusive</sup>, in the North Front A. Concession;  
Lots Numbers, One to twelve, inclusive, in the East Front B., —  
Concession; and all lying to the North of the Gore Line; (all in  
the said Township of Westmeath,) be, and are hereby formed  
into an Electoral Division to be known as Electoral Sub-division  
Number Three; and that the Polling Place for said Sub-division  
be at the School House in School Section Number Two of the  
said Township, and situated ~~near~~ <sup>near</sup> the Western end of the Gore Line  
aforesaid.

Repeal. } And that By-Law Number Nine, of 1875, be, and is  
} hereby repealed.
