

By Law No. 20 1876

A By-Law to authorize the payment of certain sums of money.

Whereas, it is necessary to pay the several sums of money hereinafter mentioned,

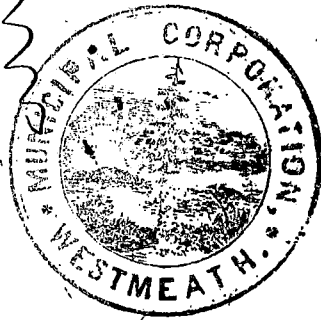
