

By-Law No. 11. — 1877.

A By-Law to authorize the Levy and Collection of certain Rates or Taxes for the year 1877, within the Township of Westmeath,

Whereas it is necessary to Levy and Collect upon all the rateable property within the Township of Westmeath in the County of Renfrew, the several hereinafter mentioned sums of money for the purposes hereinafter stated, that is to say:—

- County Rate } The sum of One thousand three hundred and <sup>and twenty two</sup>  $\frac{35}{100}$  Dollars, for County purposes;
- Township Rate } The sum of Five hundred and eighty eight  $\frac{50}{100}$  Dollars, for Township purposes;
- General School Rate } And the sum of Three hundred and eighty eight Dollars, for an equivalent to the Legislative Grant for Public Schools in said Township for the current year;

And whereas it is necessary to Levy and Collect upon all the rateable property within the several <sup>in said Township</sup> School Sections, hereinafter mentioned, the several sums of money hereinafter mentioned, for the payment of School Debentures in such Sections, that is to say,

- S. S. No. 5— In School Section No. 5, the sum of Three hundred and thirty one  $\frac{30}{100}$  Dollars;
- 7— In School Section No. 7, the sum of Two hundred and forty eight dollars;
- 8— In School Section No. 8, the sum of one hundred and thirty seven  $\frac{50}{100}$  dollars; and
- 11— In School Section No. 11, the sum of Sixty eight Dollars.

And whereas the Trustees of the several hereinafter mentioned School Sections within the said Township of Westmeath have prayed this Council to levy and Collect upon all the rateable property within their several School Sections for Special School purposes, the several sums following, viz—

- S. S. No. 1— In School Section No. 1, the sum of Two hundred and ninety five Dollars;
- 3— In School Section No. 3, the sum of Two hundred and forty two dollars;

- L.S. No. 4 - In School Section No. 4 - the sum of two hundred and twenty dollars;
- " " 5 - In School Section No. 5 - the sum of Three hundred and seventy dollars;
- " " 8 - In School Section No. 8, the sum of One hundred and ninety dollars;
- " " 9 - In School Section No. 9 - the sum of one hundred and seventy five dollars; and
- " " 11 - In School Section No. 11 - the sum of one hundred and twenty dollars - And whereas it is

It is expedient to comply with the prayer of said Trustees, therefore the Municipal Council of the Township of Westmeath in the County of Renfrew, by virtue and under the authority of an Act of the Legislature of Ontario, intituled, "An Act respecting Municipal Institutions in the Province of Ontario," and of the "Consolidated Public School Act of 1874", enacts as follows

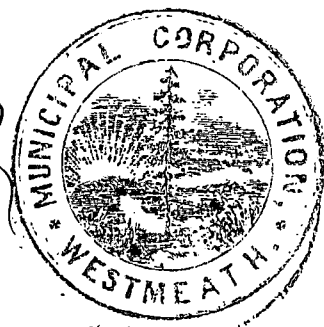
That the Collector for the said Township of Westmeath, duly appointed, shall, and such Collector is hereby authorized to levy and collect upon all the rateable property within the said Township of Westmeath, a Rate of Three and four tenths of a Mill in the dollar for County purposes; a Rate of One and five tenths of a Mill in the dollar, for Township purposes, and a Rate of One Mill in the dollar for a General School Rate, equivalent to Government Grant to Public Schools;

Upon all the rateable property in the several hereinafter mentioned School Sections in said Township for School Debentures, a Rate, in School Section No. 5 of Six and eight tenths of a Mill in the dollar, In School Section No. 7, a Rate of Four and two tenths Mills in the dollar, In School Section No. 8, a Rate of Six and nine tenths ~~of~~ Mills in the dollar, and in School Section No. 11, a Rate of Four and three tenths ~~of~~ Mills in the dollar; And also upon all the rateable property of the several hereinafter mentioned School Sections in said Township, for Special School purposes, viz - In School

No. 1. a Rate of Nine Mills in the dollar, In School Section No. 3. a Rate of Six Mills in the dollar, In School Section No. 4, a Rate of Eleven Mills in the dollar, In School Section No. 5, a Rate of Eight and one ~~teuths~~ <sup>four</sup> Mills in the dollar, In School Section No. 8, a Rate of Six and nine ~~teuths~~ <sup>four</sup> Mills in the dollar, In School Section No. 9, a rate of Eight and seven ~~teuths~~ <sup>four</sup> Mills in the dollar, and in School Section No. 11. a Rate of Seven and nine ~~teuths~~ <sup>four</sup> Mills in the dollar; and such Collector is hereby required to collect from the several persons named in the Collector's Roll for the said Township of Westmeath for the year 1877, the sum of money opposite their respective names, and to pay the sum or sums of money so collected from time to time, to the Township Treasurer; And in default of payment by any person so named and Rated, such Collector is hereby authorized and required to levy the amount by distress and sale of the goods and chattels of the person or persons so making default.

This By-Law shall take effect immediately upon and after the passing thereof.
