

By-Law No. 3, 1879.

A. By-Law to confirm the appointment of certain Township Officers,

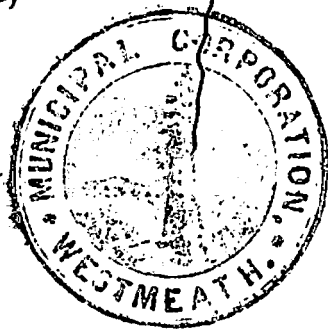
