

By-Law, No. 70, 1879

A By-Law to authorize the Levy and Collection of certain Rates or Taxes for the year 1879, within the Township of Westmeath,

Whereas it is necessary to Levy and collect upon all the rateable property within the Township of Westmeath in the County of Renfrew, the several hereinafter mentioned sums of money for the purposes hereinafter stated, that is to say:

County Rates \$1308.00/100	} The sum of One Thousand Three hundred and Eighty ^{Dollars} for County Rates.
Township Rates \$706.56	
General School Rate \$386.00	

And the sum of Three Hundred and Eighty Six Dollars for, an Equivalent to the Legislative Grant for Public Schools in said Township for the Current year;

And whereas it is necessary to Levy and collect upon all the rateable property within the several School Sections in the said Township, hereinafter mentioned, for the payment of School Debentures in such sections, that is to say:

S.S. No. 7 } In School Section No. 7, The sum of Two hundred and forty eight Dollars.

And whereas the Trustees of the several hereinafter mentioned School Sections within the said Township of Westmeath, have prayed this Council to Levy and collect upon all the rateable property within their several School Sections for special school purposes, the several sums following, viz:

S.S. No. 1 } In School Section No. 1, the sum of Two hundred and forty seven Dollars and Ninety four cents, —

S.S. No. 2 } In S.S. No. 2, Six hundred and Thirty Nine Dollars and twenty cents, —

And whereas it is expedient to comply with the prayer of said Trustees

Therefore the Municipal Corporation of the Township of Westmeath in the County of Kennew, by virtue and under the authority of an Act of the Legislature of Ontario, intituled "An Act respecting Municipal Institutions in the Province of Ontario" and of the Consolidated Public School Act of 1874" enacts as follows —

That the Collector ~~of the~~ for the said Township of Westmeath duly appointed, shall, and such collector is hereby authorized to levy and collect upon all the rateable property within the said Township of Westmeath, A. Rate of Three and Seven Tenths mills in the dollar for County purposes, A Rate of Two mills for Township purposes; A Rate of One and $\frac{2}{3}$ Mills for General school rates equivalent to the Government grant to Public Schools.

Upon all the rateable property in the several hereinafter mentioned School sections in said Township, for school Debentures, A. Rate in S. S. No. 7 of One Mill and four fifths in the dollar

And also upon all the rateable property of the several hereinafter mentioned School sections in said Township for Special School purposes Viz:

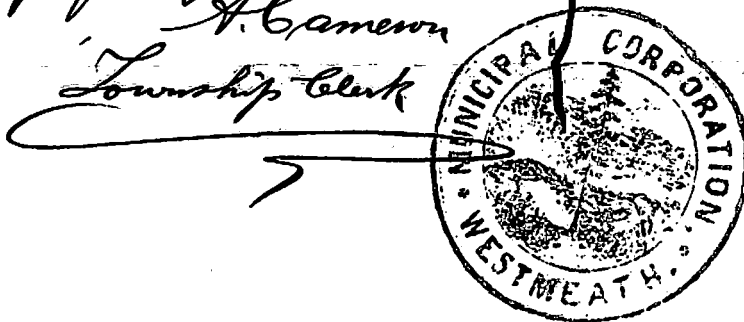
And such collector is hereby required to collect from from the several persons named in the Collector Roll for the said Township of Westmeath for the year 1879 the sum of money opposite their respective names and to pay the sum or sums of money so collected from time to time, to the Township Treasurer, and in default of payment by any so named and rated, such collector is hereby authorized to levy the amount by distress and sale of the Goods and Chattles of the persons or persons so making default.

This By-Law shall take effect immediately upon and after the passing thereof,
