

By Law No. 10. 1880.

A By-Law to authorize the Levy and Collection of certain Rates or Taxes for the year 1880, within the Township of Westmeath,

Whereas it is necessary to Levy and collect upon all the rateable property within the Township of Westmeath in the County of Benfrew, the several hereinafter mentioned sums of money for the purposes hereinafter stated,

And whereas it is expedient to comply with the prayer of said Trustees.

Therefore the Municipal Council of the Township of Westmeath in the County of Benfrew, by virtue and under the authority of an Act of the Legislature of Ontario, intituled, "An Act respecting Municipal Institutions in the Province of Ontario", and of the Consolidated Public School Act of 1874, enacts as follows —

That the Collector for the said Township of Westmeath, duly appointed, shall, and such collector is hereby authorized to Levy and Collect upon all the rateable property within the said Township of Westmeath, A Rate of Three and one Sixth (3 1/6) mills in the dollar for County purposes,

A Rate of Two Mills in the dollar for Township purposes, (2 Mills)
 A Rate of One mill and one Seventeenth ~~th~~ ~~in~~ in the dollar for
 a general School Rate Equivalent to Government Grant to Public
 School:-

Upon all the rateable property in the several hereinafter mentioned
 School Sections in said Township for School Debentures; A Rate
 in School Section No. 7, of Four and Nineteen Twentieth Mills ($4 \frac{19}{20}$)
 in the dollar,

And also upon all the rateable property of the several hereinafter
 mentioned School Sections in said Township, for Special School
 purposes Viz:-

And such collector is hereby required to collect from the several
 persons named in the collectors Roll for the said Township of
 Westmeath for the year 1880, the sum of money opposite their
 respective names, and to pay the sum or sums of money so collected
 from time to time, to the Township Treasurer; and in default of payment
 by any so named and rated; such collector is hereby authorized and
 required to levy the amount by distress and sale of the Goods and
 Chattels of the person or persons so making default,

This By Law shall take effect immediately upon and after the passing
 thereof, -
