

By Law No. 9 1882

A by law to authorize the Levy and collection of certain rates or Taxes for the year 1882 within the Township of Westmeath,

Whereas it is necessary to levy and collect upon all the rateable property within the Township of Westmeath in the County of Benfrew, the several hereinafter mentioned sums of money for the purposes hereinafter stated that is to say, -

County	}	Six Hundred and Seventy four dollars and Eighty four cents for county purposes \$674.84/100 -
Township Rate		Ten hundred and Twelve dollars and Twenty six cents for Township purposes \$1012.26/100.
General School Rate		Three Hundred and fifty four dollars and twenty nine cents for a General school Rate \$354.29/100.

And whereas the Trustees of the several hereinafter mentioned School Sections within the said Township of Westmeath have prayed this Council to Levy and collect upon all the rateable property within their several School Sections for special school purposes, the several sums following, Viz, -

And whereas it is necessary to levy and collect upon all the rateable property within the several school sections in the said Township, hereinafter mentioned for the payment of School Debentures in such sections that is to say,

- S.S. No. 7 } In school section number seven. The sum of Two hundred  
 and Forty Eight dollars \$248,00/100,

And whereas it is expedient to comply with the prayer of said Trustees

Therefore the Municipal Council of the Township of Westmeath in the county of Renfrew, by virtue and under the Authority of an act of the Legislature of Ontario intituled, "An Act respecting Municipal Institutions in the province of Ontario." and of the consolidated Public School Act of 1874 enacts as follows

That the Collector for the said Township of Westmeath, duly appointed, shall and such Collector is hereby authorized to Levy and collect upon all the rateable property within the said Township of Westmeath,

A Rate of Two mills on the dollar for county purposes (2 mills)

A Rate of Three mills in the dollar for Township purposes (3 Mills)

A Rate of One mill and one twentieth in the dollar ( $1\frac{1}{20}$ )

for a general school Rate equivalent to Government Grant to Public Schools

Upon all the rateable property in the several hereinafter mentioned School Section in said Township of School Debenture,

A Rate in School Section No. 7, Five and one fourth mills in the dollar ( $5\frac{1}{4}$  mills)

And also upon all the rateable property of the several hereinafter mentioned School Sections in said Township, for special school purposes

And such collector is hereby required to collect from the several persons named in the collectors Roll for the said Township of Westmeath for the year 1882, the sum of money opposite their respective names, and to pay the sum or sums of money so collected from time to time, to the Township Treasurer; and in default of payment by any so named and rated, such collector is hereby authorized and required to levy the amount by distress and sale of the goods and chattles of the person or persons so making default,

This by law shall take effect immediately upon and after the passing thereof
