

By Law No. 9. 1884

A by Law to authorize the Levying and collecting of certain rates or Taxes for the year 1884 within the Township of Westmeath.

Whereas it is necessary to Levy and Collect upon all the rateable property within the Township of Westmeath in the County of Renfrew, the several hereinafter mentioned sums of money for the purposes hereinafter stated

And whereas it is necessary to levy and collect upon all the rateable property ~~within~~ the several school sections in the said Township hereinafter mentioned for the payment of

And whereas it is expedient to comply with the prayer of said Trustees,

Therefore the Municipal Council of the Township of Westmeath in the County of Renfrew, by virtue and under the authority of one act of the Legislature of Ontario intitled, An Act respecting Municipal Institutions in the province of Ontario; and of the consolidated, Public Institutions in the province of Ontario; and of the consolidated Public School act of 1874, enact as follows:-

That the Collector for the said Township of Westmeath duly appointed shall and such collector is ~~to~~ hereby authorized to Levy and collect upon all the rateable property within the said Township of Westmeath. -

A Rate of Four mills for County purposes	(4 Mills)
A Rate - Three - - - - - Sp - - -	(3 - )
A Rate - One - - - - - one Cent for G.S. Rate	(1/100)

And such collector is hereby required to collect from the several persons named in the Collectors Roll for the said Township of Westmeath for the year 1884, the sum of money opposite their respective names and to pay the sums or sums of money so collected from time to time -

To the Township Treasurer and in default of payment by any so named and rated such collector is hereby authorized and required to levy the amount <sup>by</sup> distress and sale of the goods and chattles of the persons or persons so making default.

This by law shall take effect immediately upon and after passing thereof -
