

By Law No. 10. 1887

To Divide the Municipality of Westmeath into electoral or polling Sub-divisions for the election of members of the Municipal Council of the Township of Westmeath.

Be it enacted by the Municipal Council of the Corporation of the Township of Westmeath in the County of Renfrew.

That from and after the passing of this By-Law the Municipality of Westmeath shall be divided into Electoral or Polling Sub-Divisions for the election of members of the Municipal Council of the Township of Westmeath as follows, that is to say:

1. Polling Sub-Division Number One shall comprise and consist of Lots, Numbers, one to twelve inclusive in the third and fourth Concession east of the Muskrat-Lake respectively, all the Lots in the fifth Concession east of the Muskrat-Lake, Lots numbers one to fourteen inclusive in the sixth, seventh and eighth Concession respectively, Lots numbers one to twelve inclusive in the ninth and tenth Concessions respectively, and the Lots numbers eight to thirty inclusive in Concession East front B, respectively.

And that the Polling place for the said Sub-Division be at the Townhall in the village of Beaching.
2. Polling Sub-Division Number Two shall comprise and consist of ^{all the} Lots in Concessions A and B east of Muskrat-Lake; all the Lots in Concessions One and Two east of Muskrat-Lake; Lots numbers thirteen in the third and fourth Concessions, and all the Lots lying north thereof in the same Concessions, and the Lots numbers one to Twenty-four inclusive in Concession North Front A, respectively.

And that the Polling place for the said Sub-Division be at or near the place known as Moore's School House.
3. Polling Sub-Division Number Three shall comprise and consist of ^{all the} Lots numbers twenty five to thirty inclusive in the Concession N. F. A, Lots numbers fifteen in the sixth, seventh and eighth Concession and all the Lots lying north thereof in the same concessions, Lots numbers thirteen in the ninth and tenth Concessions, and all the Lots lying north thereof in the same concessions, Lots numbers one to seven inclusive in the Concession East Front B.

All the Lots in the Concession East Front C. All the Lots in the Concession North Front D. All the Lots in Concessions A and B on Coulouze Lake respectively, All the Lots in Concessions one, two, three and four from Coulouze Lake Front respectively, and all the Lots in Concession West Front E. together with the Lots in the Blank Concessions on the Lower Allynette Lake. - And that the Polling place for the said Subdivision be at or near S. S. No. 2, situated near the West End of Logan Line.

4. Polling Sub-Division Number four shall comprise and consist of the Lots in the first and second Concessions west of the Muskrat Lake, and numbered one to twenty-

seven inclusive in each of such concessions, and that the Polling place for the said Subdivision be at or near S. S. No. 8, known as Lees School House.
