

By Law No. 22. 1888

A by law to authorize the payment of certain sums of money
 Whereas it is necessary to pay to several sums of money hereinafter
 mentioned, therefore the Municipal Council of the Township
 of Westmeath in the County of Renfrew by virtue and under the
 Authority of an Act of the Legislature of Ontario.
 Enacts as follows,

That the Township Treasurer is hereby authorized to pay
