To Assess and Levy Rates or Taxes for County Township,  
General School Rate Public School Rates

Be it enacted by the Municipality Council of the Corporation of the Township  
of Westmeath in the County of Renfrew,

That the following sums be levied and collected upon and from  
all the rateable property of the Township of Westmeath for the year  
of our Lord 1891 by a rate of

The sum of  
dollars is hereby levied upon and shall be collected from all the  
rateable property of the said Township of Westmeath for County purposes  
for the year of our Lord 1891 by a rate of  $5\frac{1}{4}$  mills in the dollar,

The sum of  
dollars is hereby levied upon and shall be collected from all the rateable  
property of the said Township of Westmeath for Township purposes for the  
year of our Lord 1891, by a rate of  $4\frac{3}{4}$  Mills in the dollar,

And the further sum of  
dollars is hereby levied upon and shall be collected from all the rateable  
property of the said Township of Westmeath for General School purposes  
of the County of Renfrew for the year of our Lord 1891 by a rate of  
<sup>1</sup>/<sub>10</sub> of a cent <sup>Mills in the dollar,</sup> 5 Mills on the Dollar

And the sum of <sup>Fifteen Hundred Dollars</sup>  
shall be collected from all the rateable property of the said Township  
of Westmeath for a General Public School Rate for 1891

And be it further enacted,

That the following sums shall be levied and collected upon and  
from all the rateable property included within the limits of the several  
school sections hereinafter mentioned respectively for the year of our Lord  
1891 namely

And be it farther enacted that the rate imposed by this by law shall be collected and  
 paid over to the Treasurer of this Corporation in Bankable funds on or before the 15th day of  
 December 1891 by the collector of rates for the said Township of Westmeath in so far as the law  
 will enable him so to do.
