

By Law No. 6, 1892,  
To appoint Township officers for the year 1892,

Be it enacted by the Municipal Council of the Corporation of the Township of Westmeath in the County of Renfrew,  
That from and after the 1st day of May in the year of our Lord One Thousand Eight hundred and Ninety two  
The persons hereinafter mentioned as Overseers of Highways, Fence Viewers and Pound Keepers for the several Road Divisions of the Municipality of Westmeath be and are hereby constituted and appointed to fill the said respective offices as set forth in the Schedules hereunto annexed, marked as follows, A, Overseers of Highways, B Fence Viewers, C, Pound Keepers.

That each of the said officers hereby appointed shall on or before the first day of May 1892, next after passing of this by law make and subscribe the necessary declaration of offices and shall continue to hold such respective offices as follows aforesaid, until his or their successors has been duly appointed and qualified or until otherwise relieved by this Council.

And be it further enacted

That the Schedules A, B, and C, hereunto annexed shall form and be a part of this by-law.

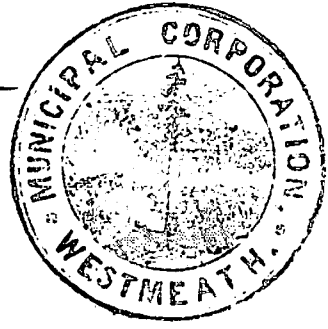
