

To provide for the licensing of Victualling houses, Ordinaries and houses where fruits, oysters, clams or victuals are sold to be eaten therein and other places for reception, refreshment or entertainment of the public.

Whereas it is necessary to provide for the Issuing of licenses to keepers of Victualling houses, Ordinaries and houses where fruits, oysters, clams or victuals are sold to be eaten therein and other places for reception, refreshment or entertainment of the public, within the limits of the Municipality of the Township of Westmeath.

THEREFORE the Municipal Corporation of the Township of Westmeath in the County of Renfrew, enacts as follows: -

(1): - That no person or persons shall keep a victualling house an Ordinary or a house where fruit, oysters, clams or victuals are sold to be eaten therein, or other place for reception, refreshment or entertainment of the public within the limits of the Municipal Corporation of the Township of Westmeath without being duly licensed therefor.

(2): - That all persons desirous of keeping a house of the kind and for the purposes in the preceding section mentioned shall pay for a license therefor, the sum of Twenty Dollars.

(3): - That all licenses issued under this By-Law shall commence and take effect from the first day of May in each year and end on the Thirtieth day of April in the following year.

(4): - That the Clerk of the Municipality is hereby empowered and required upon the application of any person for a license for the purposes in said first section mentioned and upon payment of the said sum of Twenty Dollars, the fee above provided, to issue under his hand and the seal of the Corporation a license in the form hereinafter set out authorizing such person to keep such a house as aforesaid and the said Clerk is hereby empowered to charge, collect and receive from every such party obtaining such a license for his own use and benefit, in addition to the said License fee, the sum of One Dollar.

(5): - That the license before referred to shall be in the form

before mentioned or in any way violating the provisions of this By-Law, shall upon conviction before any one of Her Majesty's Justices of the Peace forfeit and pay a penalty of not less than One Dollar nor more than Twenty Dollars and all lawful costs besides and in default of payment of the fine and costs it shall be lawful for such convicting Justice to issue a Warrant of distress and failing sufficient distress to commit the offender or offenders to gaol for any period not exceeding Twenty days nor less than one day.

(7):- That nothing in this By-Law contained shall authorize or permit any person to sell in any manner any fermented or spirituous liquors.

(8):- That all by-laws inconsistent with this By-Law are hereby repealed.
