

# Taxes

By Law No. 19. 1893.

To Assess and Levy Rates or Taxes for County Township  
General School Rates Public School Rates,  
Be it enacted by the Municipal Council of the Corporation of the  
Township of Westmeath in the County of Renfrew,

That the following sums be levied and collected upon and  
from all the rateable property of the Township of Westmeath  
for the year of our Lord 1893.

The sum of \$1645.64

Dollars is hereby levied upon and shall be collected from  
all the rateable property of the said Township of Westmeath for  
County purposes for the year of our Lord 1893 by a  
Rate of  $5\frac{1}{2}$  mills in the Dollar

The sum of \$1570.84

Dollars is hereby levied upon and shall be collected from  
all the rateable property of the said Township of Westmeath  
for Township purposes for the year of our Lord 1893.  
by a rate of  $5\frac{1}{4}$  Mills in the Dollar,

And the further sum of \$374.00

Dollars is hereby levied upon and shall be collected from all  
the rateable property of the said Township of Westmeath for  
General School purposes of the County of Renfrew for the  
Year of our Lord 1893. by a Rate of  $1\frac{1}{4}$  Mills in the Dollar

And the further sum of \$600.00

Dollars is hereby levied upon and shall be collected from  
all the rateable property of the said Township of Westmeath  
for Public School Rate for the year of our Lord 1893 by a  
Rate of Mills in the Dollar.

And be it further enacted,

That the following sums shall be levied and collected  
upon and from all the rateable property included within the  
limits of the several School Sections hereafter mentioned  
respectively for the year of our Lord 1893. namely,
