

By-Law No. 16 1895

To Assess and Levy Rates or Taxes for County Township General School Rates and Public School Rates.

Be it enacted by the Municipal Corporation of the Township of Westmeath in the County of Renfrew That the following sums be levied and collected upon and from all the rateable property of the Township of Westmeath for the year of our Lord 1895-

The sum of \$1846.⁰⁰ is hereby levied upon and shall be collected from all the rateable property of the said Township of Westmeath for County purposes for the year of our Lord 1895 by a rate of 6 1/2 mills on the dollar.

The sum of \$1578.07 is hereby levied upon and shall be collected from all the rateable property of the Township of Westmeath for Township purposes for the year of our Lord 1895 by a rate of 5 1/2 mills on the dollar.

The sum of \$390.00 is hereby levied upon and shall be collected from all the rateable property of the said Township of Westmeath for General School Purposes for the year of our Lord 1895 by a rate of 5 1/2 mills on the dollar.

And the further sum of \$1542.79 is hereby levied ^{upon} and shall be collected from all the rateable property of the said Township of Westmeath for Public School Rates for the year of our Lord 1895 by a rate of 5 1/2 mills on the dollar.

And be it further enacted that the following sums shall be levied and collected upon and from all the rateable property included within the limits of the several School Sections hereinafter mentioned respectively for the year of our Lord 1895 - viz: -

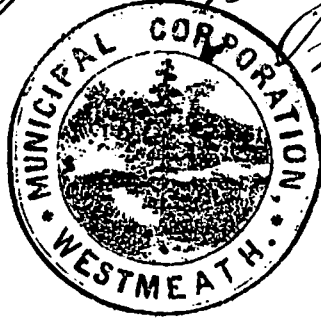
