

By-Law No 13 1896

To assess and levy Rates or Taxes for County Township, General School and Public School

Be it enacted by the Municipal Corporation of the Township of Westmeath in the County of Renfrew that the following sums be levied and collected upon and from all the rateable property of the Township of Westmeath for the year of our Lord 1896.

County Levy
\$1790.⁰⁰

The sum of \$1790.⁰⁰ is hereby levied upon and shall be collected from all the rateable property of the said Township of Westmeath for County purposes for the year of our Lord 1896 by a rate of 6 $\frac{1}{2}$ mills on the dollar.

Township Levy
\$1600.⁰⁰

The sum of \$1600.⁰⁰ is hereby levied upon and shall be collected from all the rateable property of the said Township of Westmeath for Township purposes for the year of our Lord 1896 by a rate of 5 $\frac{1}{2}$ mills on the dollar.

P.S. Levy
\$2363.84

And the further sum of \$2363.84 is hereby levied upon and shall be collected from all the rateable property of the said Township of Westmeath for General School purposes for the year of our Lord 1896 by a rate of 8.2 mills on the dollar.

And be it further enacted that the following sums shall be levied upon and collected from all the rateable property included within the limits of the general school sections herein after mentioned respectively for the year of our Lord 1896 viz:—

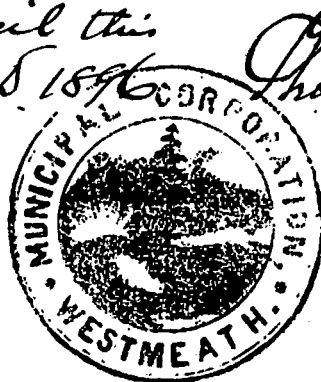
