

By-Law No 14 1897

To Levy and Collect Rates and Taxes for County, Township, Educational and other purposes

Be it enacted by the Municipal Corporation of the Township of Westmeath in the County of Renfrew that the following sums be levied and collected upon and from all the rateable property of the Township of Westmeath for the year of our Lord 1897

County Rate
\$1781.00

The sum of \$1781.00 is hereby levied upon and shall be collected from all the rateable property of the said Township of Westmeath for County purposes for the year of our Lord 1897 by a rate of 6.2 mills on the \$.

Township Rate
\$2500.00

The sum of \$2500.00 is hereby levied upon and shall be collected from all the rateable property of the said Township of Westmeath for Township purposes for the year of our Lord 1897 by a rate of 8.6 mills on the \$.

Special School
\$2363.70

And the further sum of \$2363.70 is hereby levied upon and shall be collected from all the rateable property in the said Township of Westmeath for Special School purposes for the year of our Lord 1897 by a rate of 8.2 mills on the dollar.

And be it further enacted that the following sums shall be levied upon and collected from all the rateable property included within the limits of the several School Sections hereinafter mentioned respectively for the year of our Lord 1897 viz:—
