

By-Law No 4 1898

A By-Law to appoint Township officers for the year 1898

Be it enacted by the Municipal Council of the Township of Westmeath that on and after the 1st day of May 1898 that the persons herein after mentioned as Overseers of Highways Fence Viewers and Poundkeepers for the several divisions of the Municipality of Westmeath be and they are hereby constituted and appointed to fill the said respective offices as set forth in the Schedule herewith annexed marked A, B, & C

That each of the said officers hereby appointed shall on or before the 1st day of May next after the passing of this By-Law make and subscribe the necessary declaration of office and shall continue to hold such respective offices as aforesaid until his or their successors have been appointed and qualified or until otherwise relieved by this council.

And be it further enacted:-

That the schedule marked A be filled in with the names of the overseers
That the schedule marked B be filled in with the names of the fence viewers
That the schedule marked C be filled in with the names of the Poundkeepers
