

By-Law No. 13 1898.

To assess and levy Rates or Taxes for County Township, General School and Public School.

Be it enacted by the Municipal Corporation of the Township of Westmeath in the County of Renfrew that the following sums be levied and collected upon and from all the rateable property of the Township of Westmeath for the year of our Lord 1898.

County Levy  
\$1781.00

The sum of \$1781.00 is hereby levied upon and shall be collected from all the rateable property of the said Township of Westmeath for County purposes for the year of our Lord 1898 by a rate of 2 Mills on the Dollar.

Township Levy  
\$1600.00

The sum of \$1600.00 is hereby levied upon and shall be collected from all the rateable property of the said Township of Westmeath for Township purposes for the year of our Lord 1898 by a rate of 5 1/2 Mills on the Dollar.

P.S. Levy  
\$2363.25

And the further sum of \$2363.25 is hereby levied upon and shall be collected from all the rateable property of the said Township of Westmeath for General School purposes for the year of our Lord 1898 by a rate of 8.2 Mills on the Dollar.

And be it further enacted that the following sums shall be levied upon and collected from all the rateable property included within the limits of the several school sections herein after mentioned respectively for the year of our Lord 1898

- viz: - Separate School No. 2, Stafford 20 Mills on the \$
- S. S. No 1 - 5 Mills on the \$
- S. S. No 2 - 11 Mills on the \$

And be it further enacted that the rates imposed by this By-Law shall be collected and paid over to the Treasurer of the Corporation in Bankable funds, on or before the 15<sup>th</sup> day of December 1898 by the collection of rates for the said Township of Weststrate in so far as the law will enable him so to do
