

By-law No. 19 - 1900

To assess and levy rates or taxes  
for County; Township; General and  
Public School.

Be it enacted by the  
Municipal Corporation of the Township  
of Westmeath in the County of Renfrew  
that the following sums be levied  
and collected upon and from all  
the rateable property of the Township  
of Westmeath for the year of our Lord  
1900

The sum of \$ 16 70<sup>00</sup> is hereby  
levied upon and shall be collected  
from all the rateable <sup>property</sup> in the said Town-  
ship of Westmeath for County purposes  
for the year 1900 by a rate of 6 mills  
on the \$.

The sum of \$ 16 17<sup>xx</sup> is hereby  
levied upon and shall be collected from  
all the property in the said Township of  
Westmeath for Township purposes for the  
year 1900 by a rate of 5<sup>1/2</sup> mills on  
the \$.

The sum of \$ 2380<sup>00</sup> is hereby  
levied and shall be collected from all  
the rateable property of the said Township  
of Westmeath for General School purposes  
for the year 1900 by a rate of 8<sup>1/2</sup> mills  
on the \$.

And be it further enacted that  
the following sums shall be levied upon  
and collected from all the rateable

property included within the limits of the several school sections hereafter mentioned respectively for the year 1900

viz:- S. S. No. 1 - - -	5' mills on the \$

And be it further enacted that the following sums shall be levied and collected upon and from all the taxable property within the limits of the following school sections for the purpose of paying debts due for the following schools for the year 1900

S. S. No. 10 - - -	16 " "


And be it further enacted that the rates imposed by this Bylaw shall be

collected and paid over to the Treasurer  
of the corporation of the Township of Westmeat  
in Bankable funds on or before the 15<sup>th</sup>  
day of December A.D. 1908. by the Collector  
of rates for the said Township of Westmeat  
so far as the Law will enable him  
to do
