

By-Law No. 20

A By-Law to open and establish a High-way upon Private lands.

W H E R E A S the Municipal Corporation of the Township of Westmeath have purchased from Alexander Bromley and have obtained a deed from him of the lands hereinafter particularly described, for the purposes of a public travelled Road or Highway, and it is necessary to open and establish the same by By-Law.

NOW THEREFORE THE MUNICIPAL CORPORATION OF THE TOWNSHIP OF WESTMEATH hereby that the following lands shall be opened and established as a public Road or Highway, namely; -ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Township of Westmeath in the County of Renfrew and Province of Ontario, Being composed of a Part of Lot number FIVE in the SECOND CONCESSION Coulonge Lake Front of said Township, and which may be better known and described as follows; -Commencing at a point on the Northern boundary of said Lot number Five distant 4 chains and 31 links from the north-west angle of said lot measured South 77 degrees 56 minutes East along said northern boundary; thence from said point as a centre of a forced road with a width of 20 feet on each side of said centre, measured at right angles to the centre line of said road, South 1 degree 11 minutes East, 3 chains and 70 and $\frac{1}{3}$ links; thence South 3 degrees and 19 minutes West, 1 chain and 72 and $\frac{1}{2}$ links; thence south 23 degrees West 1 chain and 38 and $\frac{1}{3}$ links; thence South 46 degrees 40 minutes 2 chains and 91 and $\frac{1}{2}$ links; thence South 33 degrees and 20 minutes West 1 chain and 97 and $\frac{1}{3}$ links; thence South 49 degrees and 28 minutes West 1 chain and 90 links to a point of intersection with the western boundary of said lot, which point of inter-

section is 12 chains and 65 links from the said North-West angle
of said Lot Five measured South 4 degrees West along the said
western boundary, and containing by admeasurement 924/1000 of an
Acre.

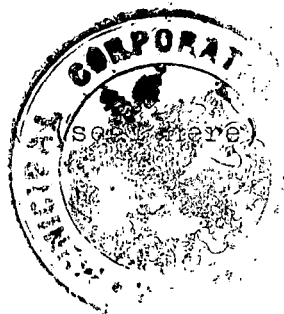
