

By Law No. 13, 1901,

To assess and levy rates or Taxes for County, Township, General and Public School purposes

Be it enacted by the Municipal Corporation of the Township of Westmeath in the County of Newfane that the following sums be levied and collected upon and from all the rateable property of the Township of Westmeath for the year of our Lord 1901

The sum of \$1764<sup>10</sup> is hereby levied upon and shall be collected from all the rateable property in the said Township of Westmeath for County purposes for the year 1901 by a rate of 6 mills on the \$

The sum of \$1617<sup>10</sup> is hereby levied upon and shall be collected from all the rateable property in the said Township of Westmeath for Township purposes for the year 1901 by a rate of 5<sup>1</sup>/<sub>2</sub> mills on the \$

The sum of \$2499<sup>14</sup> is hereby levied and shall be collected from all the rateable property of the said Township of Westmeath for general school purposes for the year 1901 by a rate of 8<sup>1</sup>/<sub>2</sub> mills on the \$

And be it further enacted that the following sums shall be levied upon and collected from all the rateable

property included within the limits of  
 the several school sections hereinafter  
 mentioned respectively for the year 1907

 rates imposed by this By Law shall be

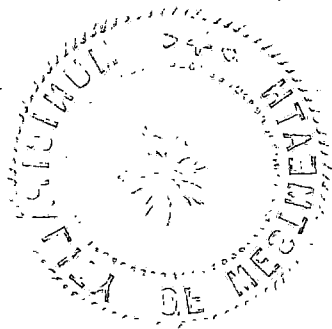
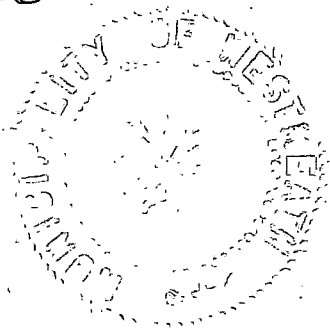
collected and paid over to the Treasurer
