

Bylaw No. 16, 1903

To assess and levy rates or taxes for County, Township, General and Public School purposes.

Be it enacted by the Municipal Corporation of the Township of Westmeath in the County of Renfrew that the following sums be levied and collected upon and from all the rateable property of the Township of Westmeath for the year of our Lord 1903

County Rates

The sum of \$1873.<sup>\*\*</sup> is hereby levied upon and shall be collected from all the rateable property in the said Township of Westmeath for County purposes for the year 1903 by a rate of  $6\frac{3}{8}$  mills on the \$

Township

The sum of \$1795.<sup>\*\*</sup> is hereby levied and collected upon and shall be collected from all the rateable property in the Township of Westmeath for Township purposes for the year 1903 by a rate of 6 mills on the \$

Gen. School

The sum of \$2310.<sup>\*\*</sup> is hereby levied and shall be collected from all the rateable property of the said Township of Westmeath for General School purposes for the year 1903 by a rate of  $7\frac{5}{8}$  mills on the \$

And be it further enacted that the following sums shall be levied and collected from all the rateable property

included within the limits of the several school sections herein after mentioned respectively for the year 1903

And be it further enacted that the rates imposed by this Bylaw shall be collected and paid over to the Treasurer of the Corporation of the Township of Westmeath in

Bankable funds on or before the 15<sup>th</sup>  
day of December 1903 by the Collector of  
Rates for the said Townships of Tredwell  
in as far as the law will enable him  
to do so
