

Bylaw No. 1904

A Bylaw to assess and levy rates or Taxes for County, Township and General and Public School purposes:-

Therefore be it enacted by the Municipal Corporation of the Township of Westmeath in the County of Kennebec that the following sums be levied and collected upon and from all the rateable property of the Township of Westmeath for the year of our Lord 1904

1st. The sum of \$1888^{xx} is hereby levied upon and shall be collected from all the rateable property in the said Township of Westmeath for County purposes for the year 1904 by a rate of $6\frac{3}{8}$ mills on the \$

2nd. The sum of \$1727^{xx} is hereby levied upon and shall be collected from all the rateable property in the Township of Westmeath for Township purposes for the year 1904 by a rate of $5\frac{7}{8}$ mills on the \$

3rd. The sum of \$2300^{xx} is hereby levied and shall be collected from all the rateable property of the said Township of Westmeath for General School purposes for the year 1904 by a rate of $7\frac{3}{4}$ mills on the \$

4th. And it is further enacted that the following sums shall be levied and collected from all the rateable property included within the limits of the several School Sections herein after mentioned respectively for the year 1904

And be it further enacted that the notes imposed by this Bylaw shall be collected and paid over to the Treasurer of the Corporation of the Township of Westmeath on Bankable funds on or before the 15th day of December 1904 by the collector of notes for the said Township of Westmeath in as far as the law will enable him to do so
