

B Y - L A W N O. 6

To Amend By-Law No.11 of 1905 passed on the 10th. day of June A.D. 1905.

WHEREAS the Municipal Council of the Township of Westmeath on the 10th.day of June A.D.1905 passed a by-law to raise by way of loan the sum of Five thousand dollars for the purpose of purchasing a school site and building a school house thereon, in and for Public School Section Number Two in the said Township of Westmeath.

AND WHEREAS by the said By-law it was provided that the Debentures to be issued by virtue of the said by-law should be made payable in Twenty years at furthest and should be dated the 31st day of December A.D.1905 and that such debentures and interest Coupons should be payable on the 30th.day of December in each and every year during the said twenty years.

AND WHEREAS at the time of the passing of said by-law the fact was overlooked, that the 31st.day of December A.D.1905 fell on Sunday, and although the by-law was passed on the tenth day of June (which was not a Sunday) doubts are expressed as to the validity of said debentures issued by virtue hereof and this by-law is passed to remedy the defect of said by-law No.11 of 1905 in the respect mentioned.

THEREFORE THE MUNICIPAL COUNCIL of the Township of WESTMEATH ^{enacts} as follows;-

1. That said By-law No.11 of 1905 of the said Corporation of the Township of Westmeath be and is hereby amended as follows That Clause 4 of said by-law be amended by striking out the date "31st." where it appears therein and substituting therefor the date 30th. and also by striking out the date "thirtieth" where it appears therein and substituting therefor the date "twenty-ninth".
2. That clause 5 of said by-law be amended by striking out the date "31st." where it appears therein and substituting therefor the date "thirtieth".
3. That it shall be lawful for the Reeve and Clerk of the said

Township to make the necessary corrections in the Debentures already issued by virtue of said by-law No.11 so as to make them conform to this by-law and also for the Reeve and Treasurer to so amend the several coupons attached to said Debentures as to make them conform to this by-law.

4. In the alternative, if it should be found necessary or advisable, that the Reeve and Clerk be authorized and empowered to issue new debentures for the said moneys and to sign and seal the same and for the said Reeve and Treasurer to sign all coupons so as to make the same conformable to said by-law No.11 as amended by this by-law.

5. That this by-law take effect upon the passing thereof.
